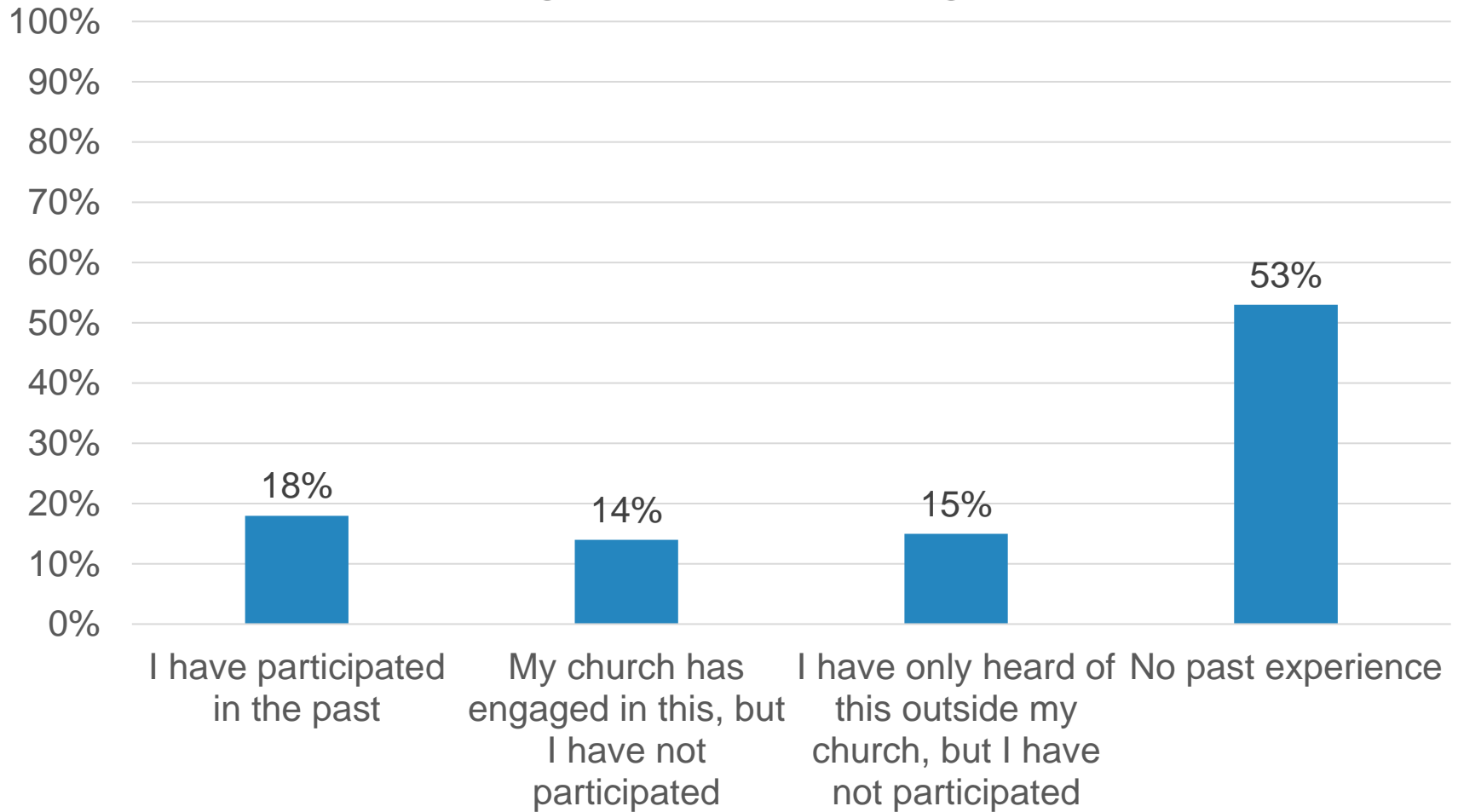
# Methodology

- The study was sponsored by Correctional Ministries Institute at Wheaton College Billy Graham Center, Prison Fellowship, Correctional Ministries and Chaplains Association, and Kairos Prison Ministries
- The online survey of 1,006 American Protestant churchgoers was conducted January 8-12, 2024, using a national pre-recruited panel
- Respondents were screened to include those who identified as Protestant/non-denominational and attend religious services at least once a month
- Quotas and slight weights were used to balance gender, age, region, ethnicity, education, and religion to more accurately reflect the population
- The completed sample is 1,006 surveys
- The sample provides 95% confidence that the sampling error from the panel does not exceed  $\pm 3.2\%$ . This margin of error accounts for the effect of weighting
- Margins of error are higher in sub-groups
- Percentages may not total due to rounding

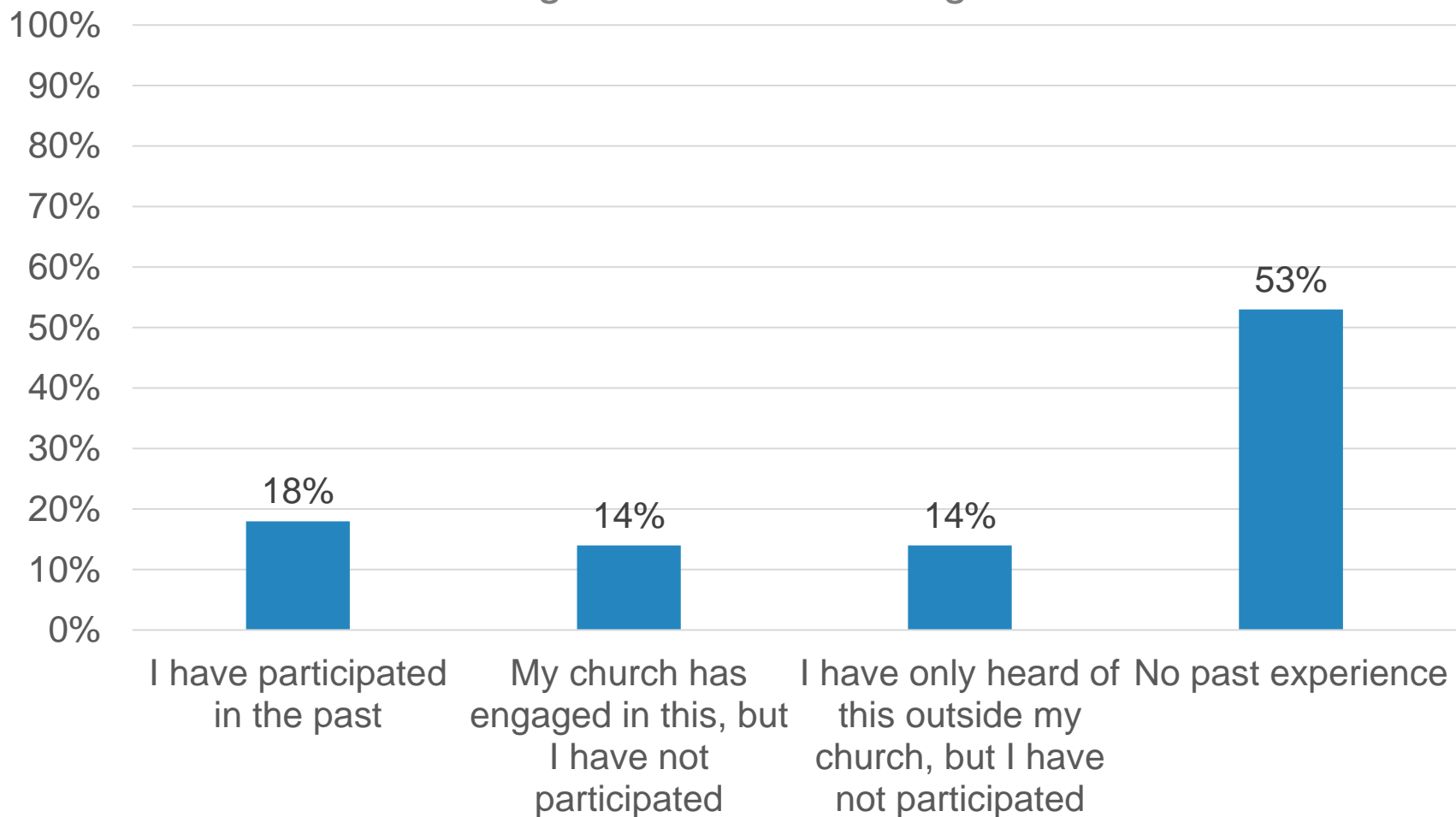

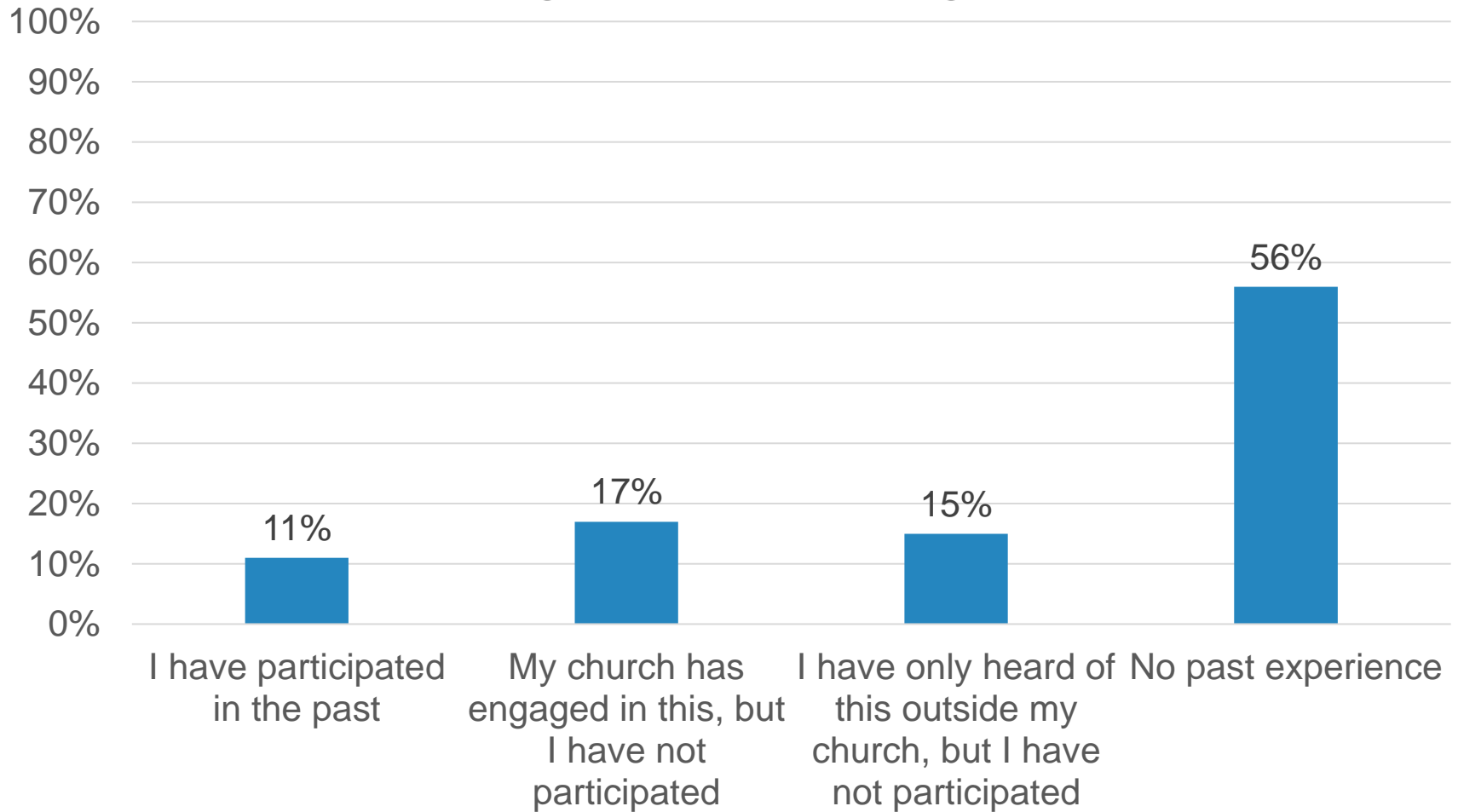

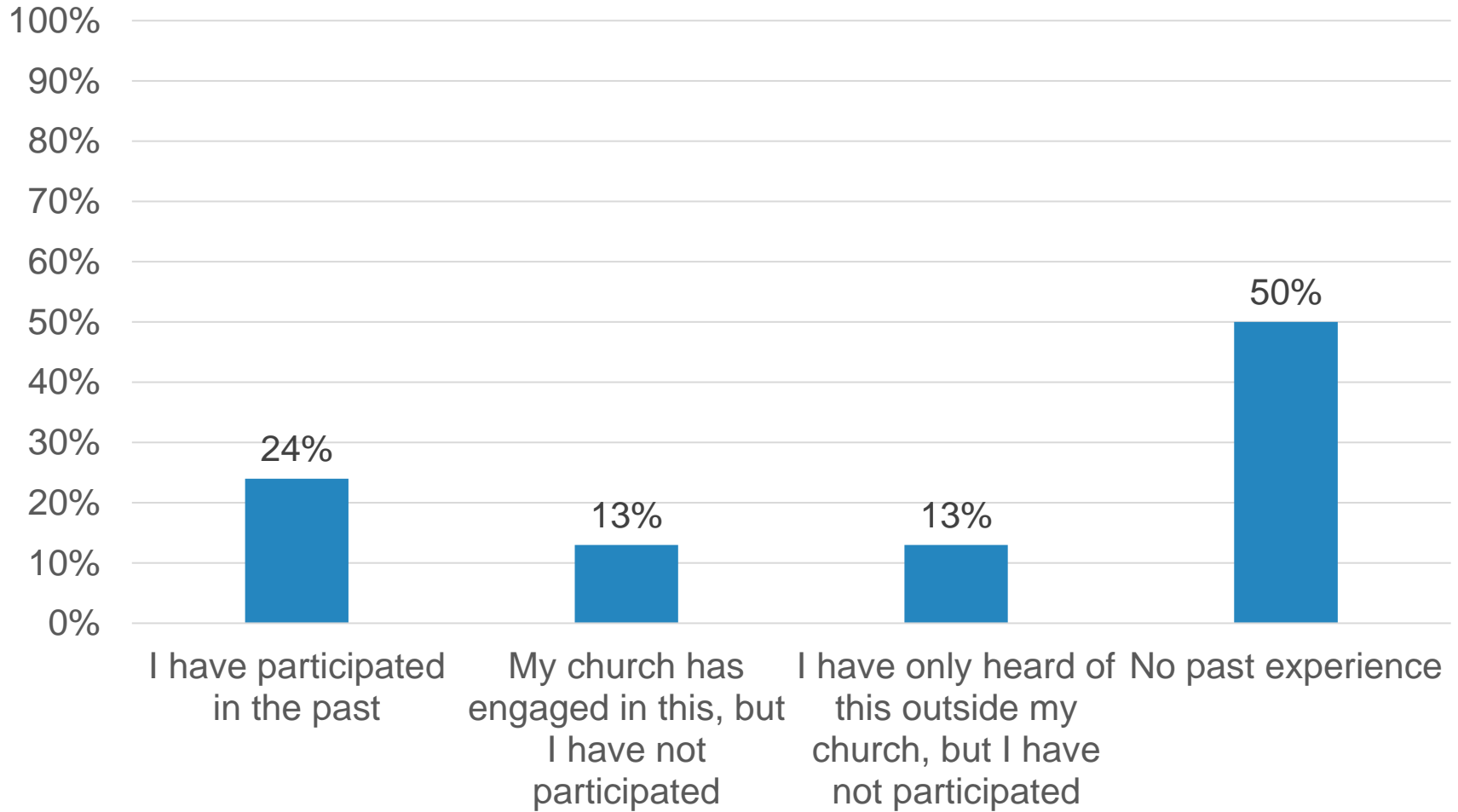

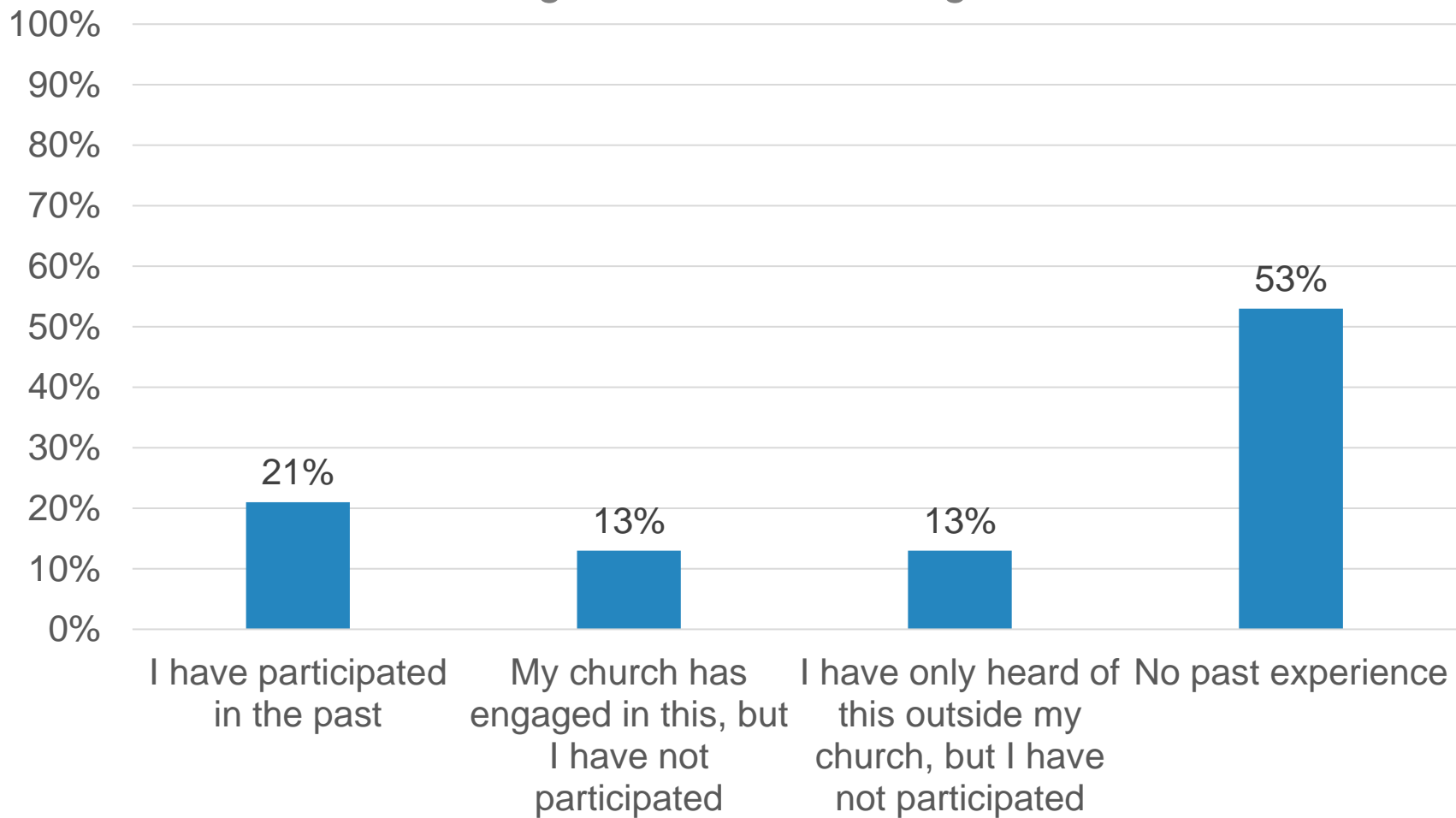

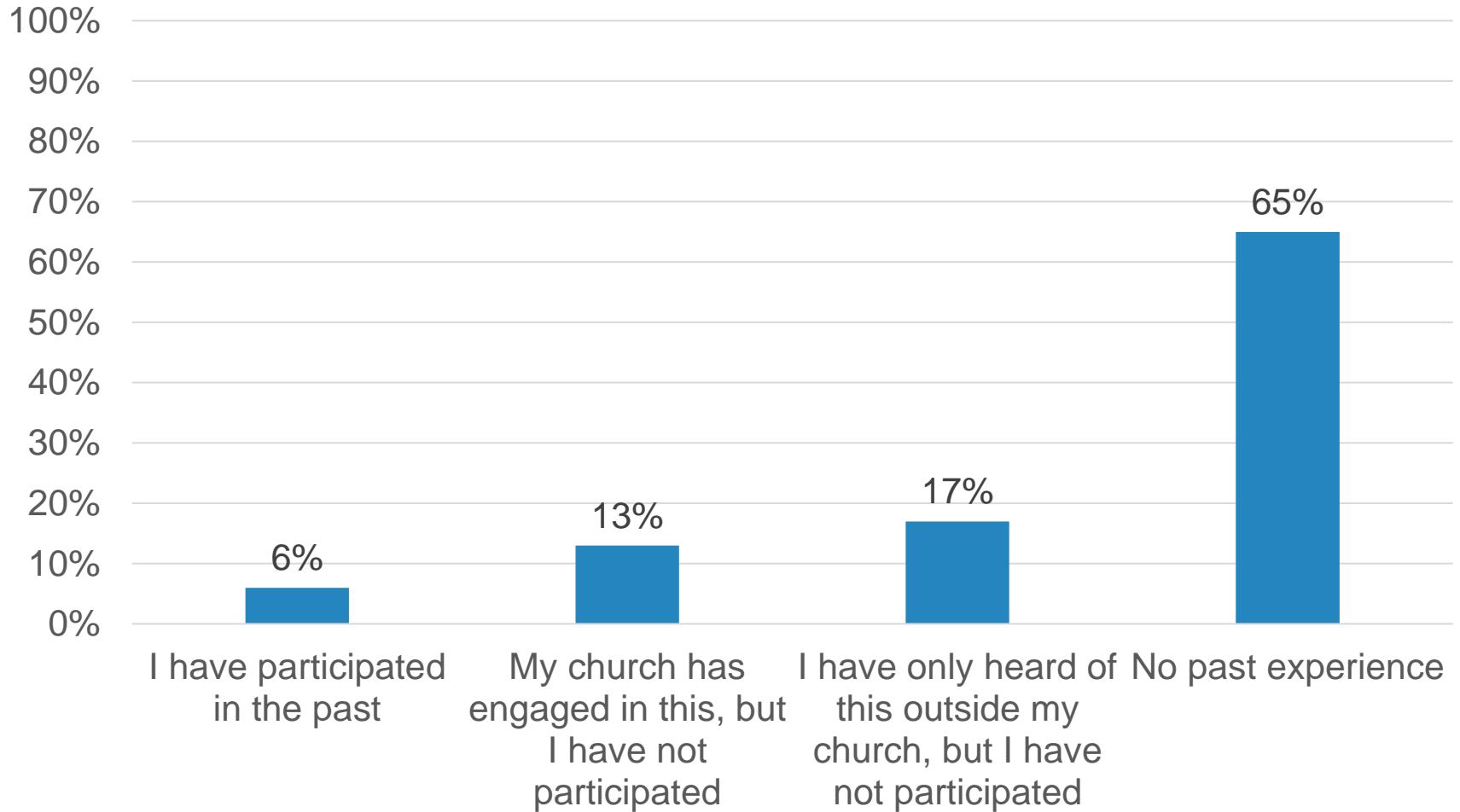

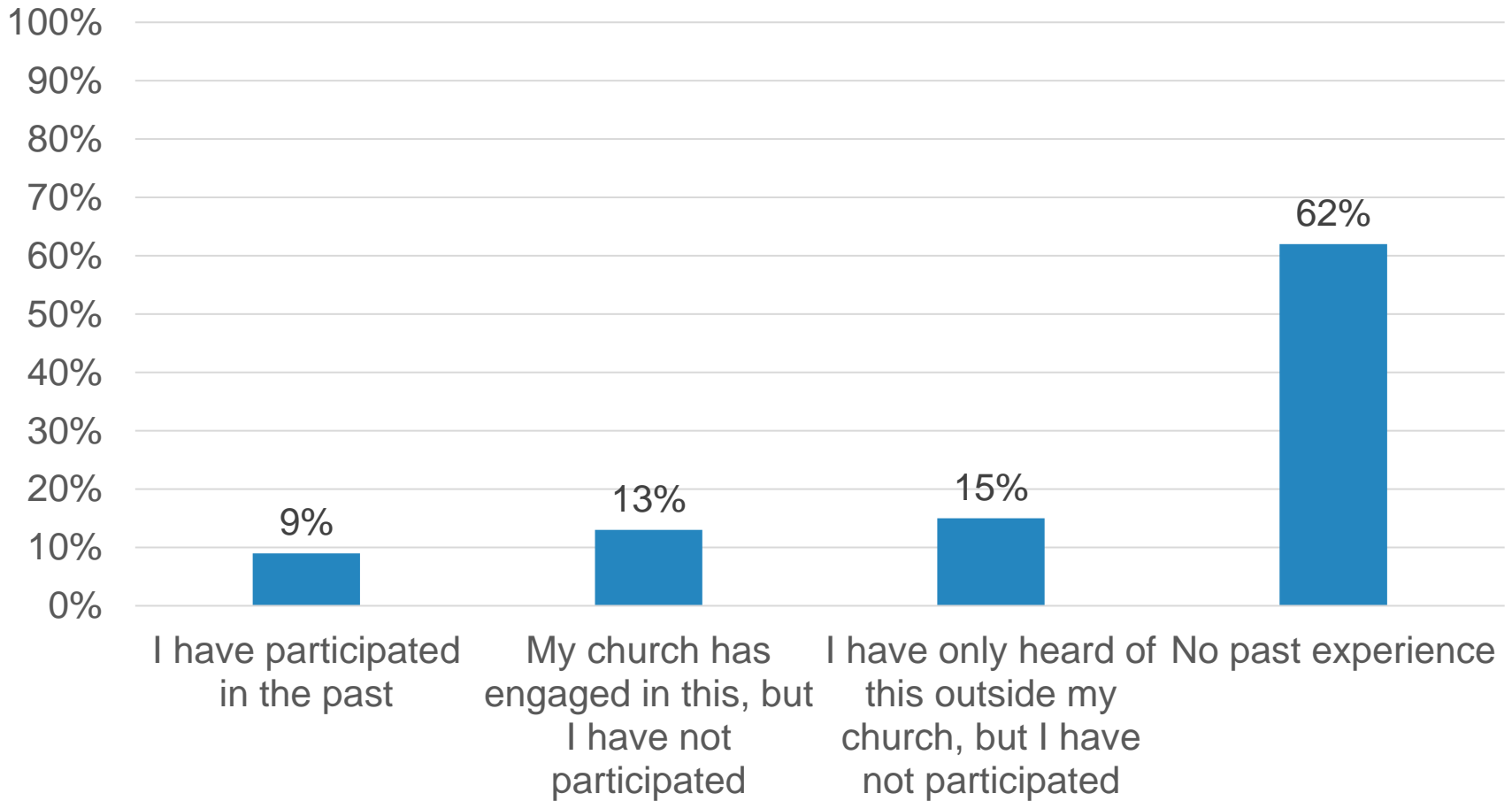

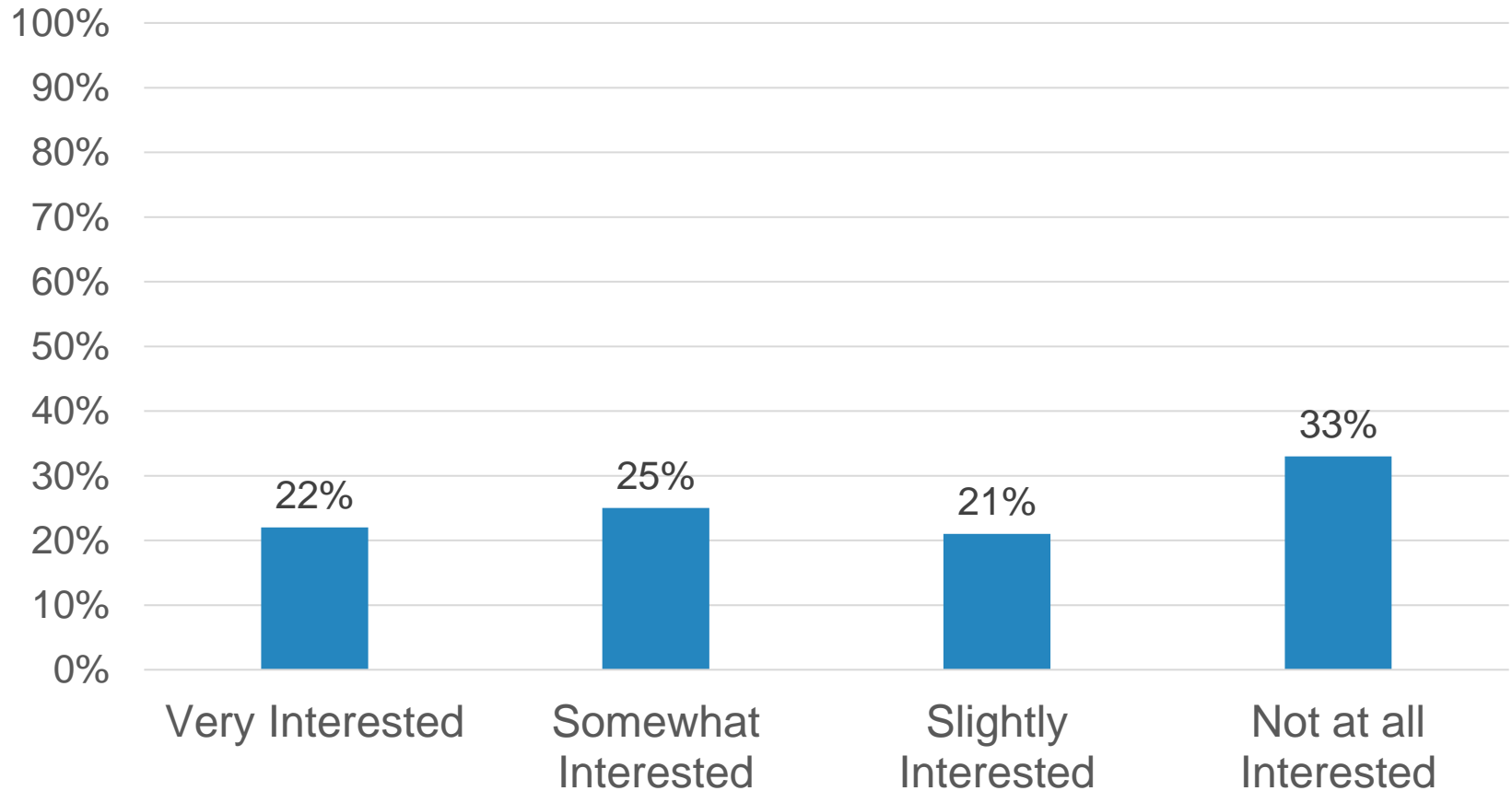

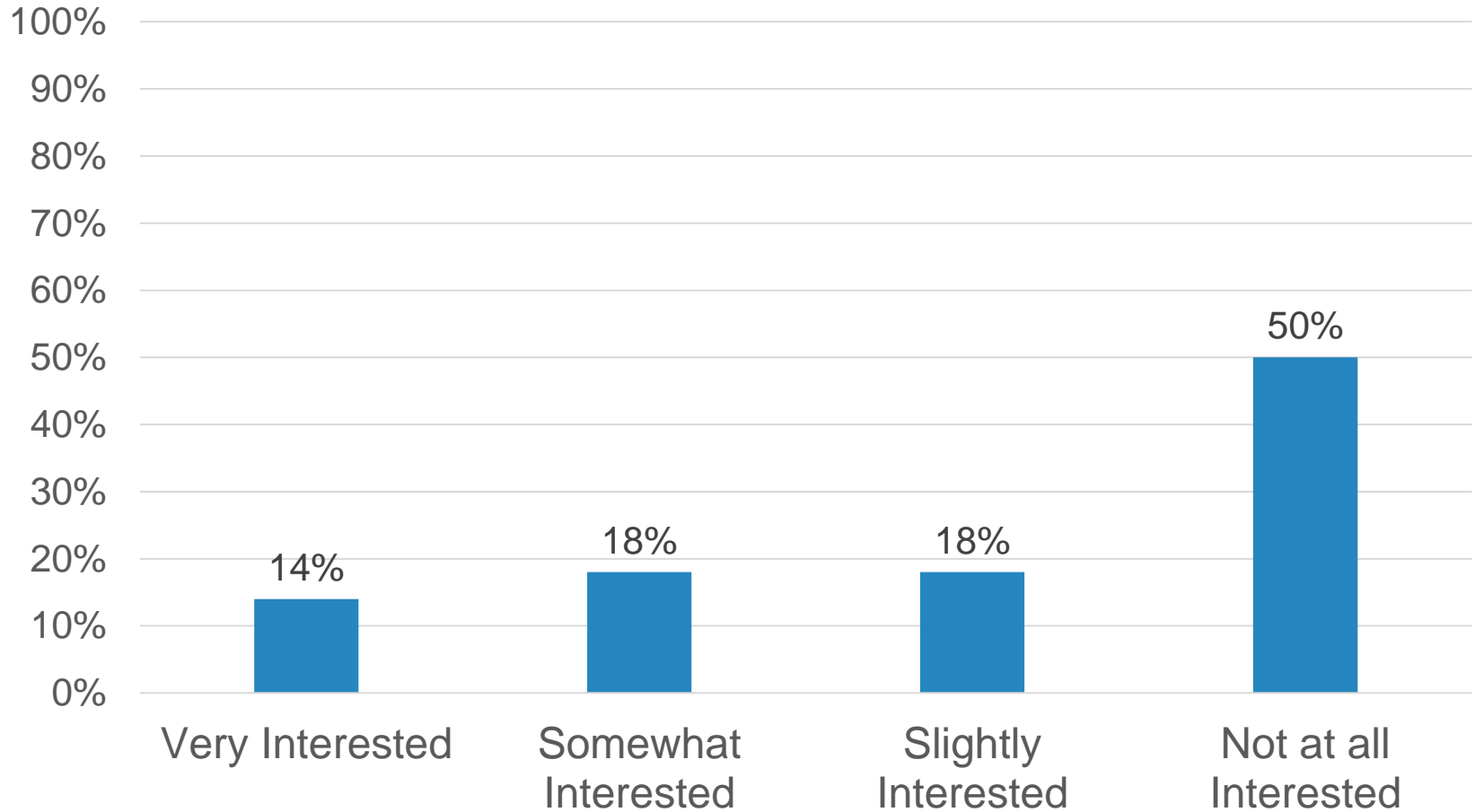

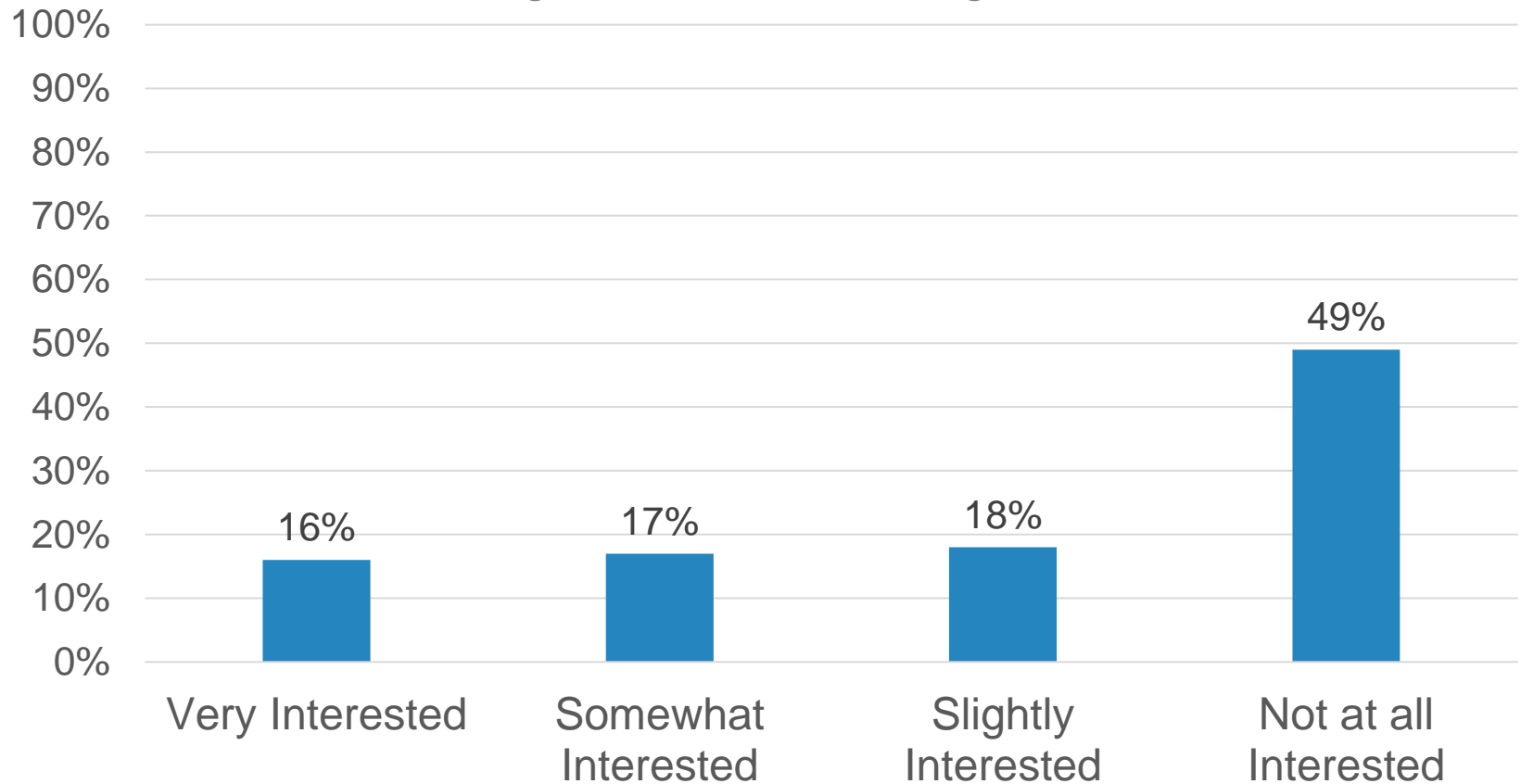

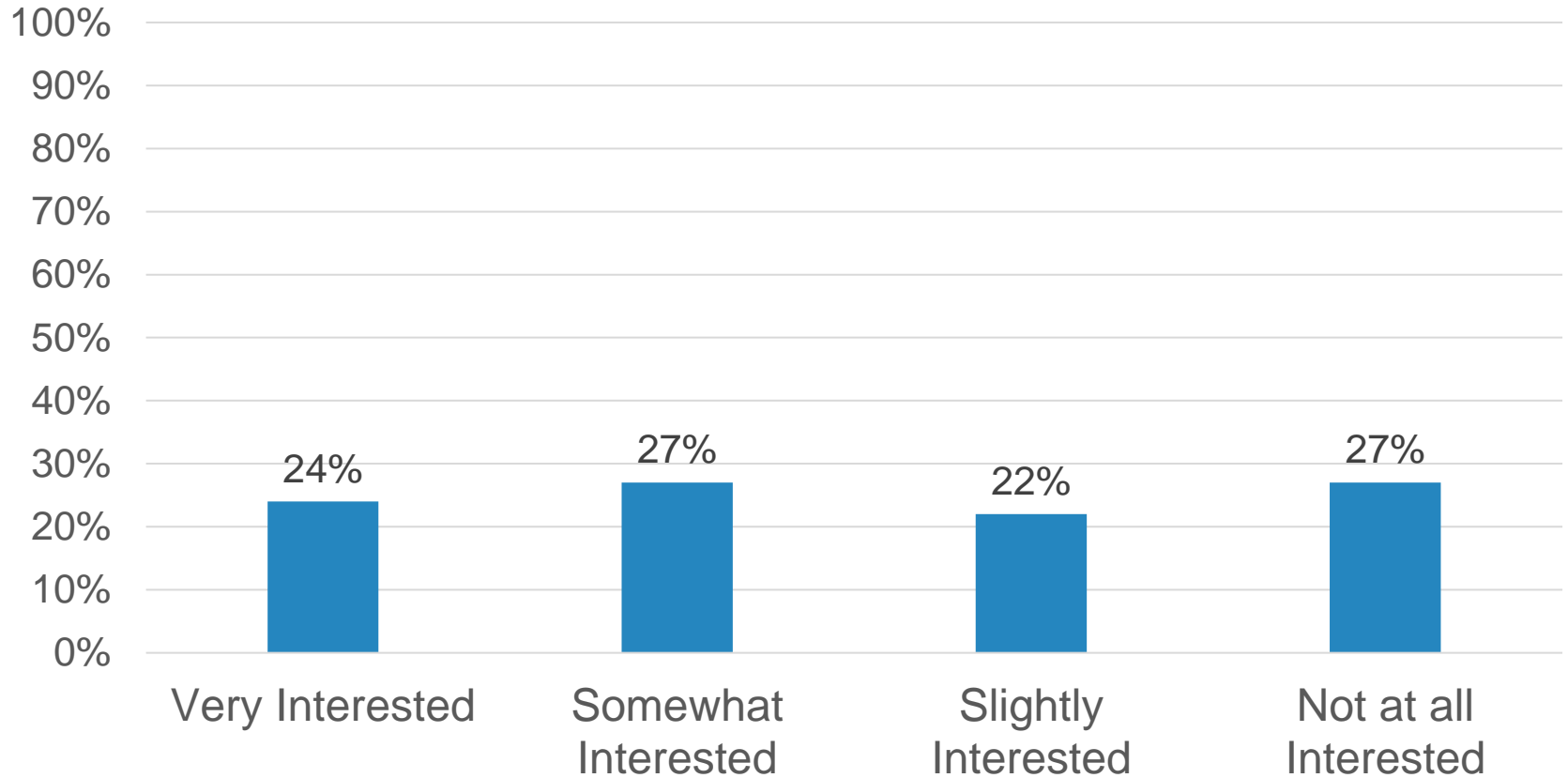

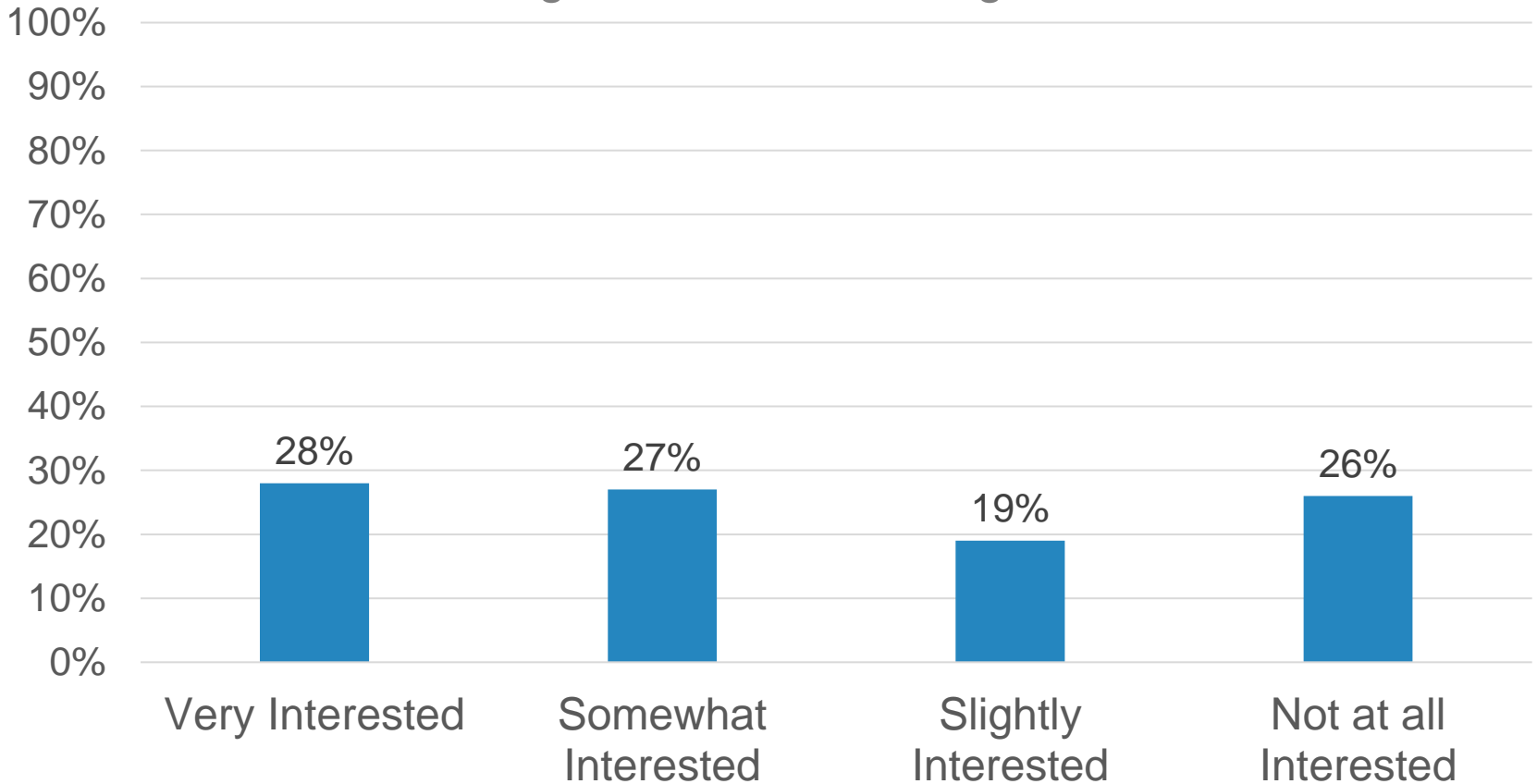

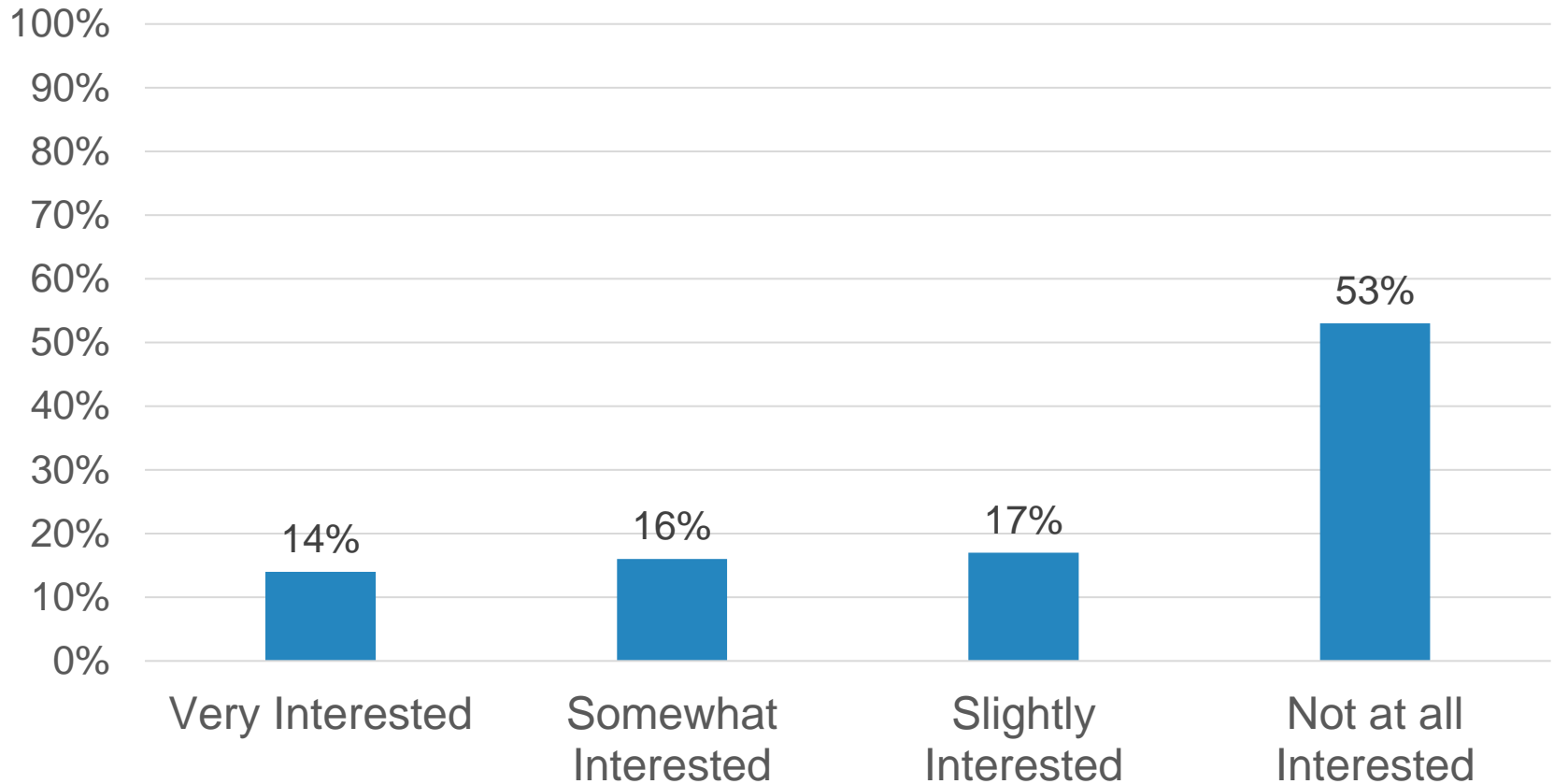

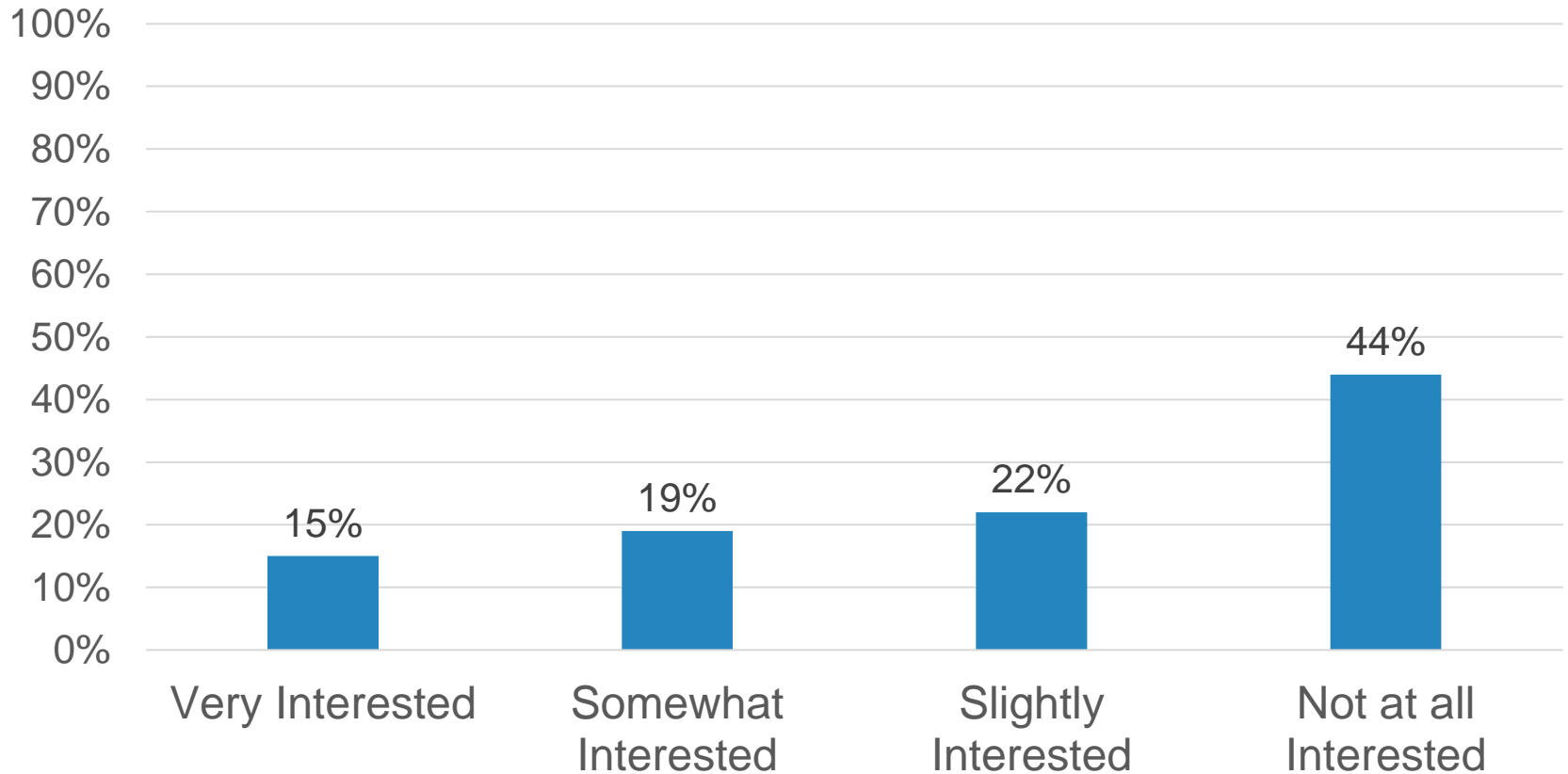

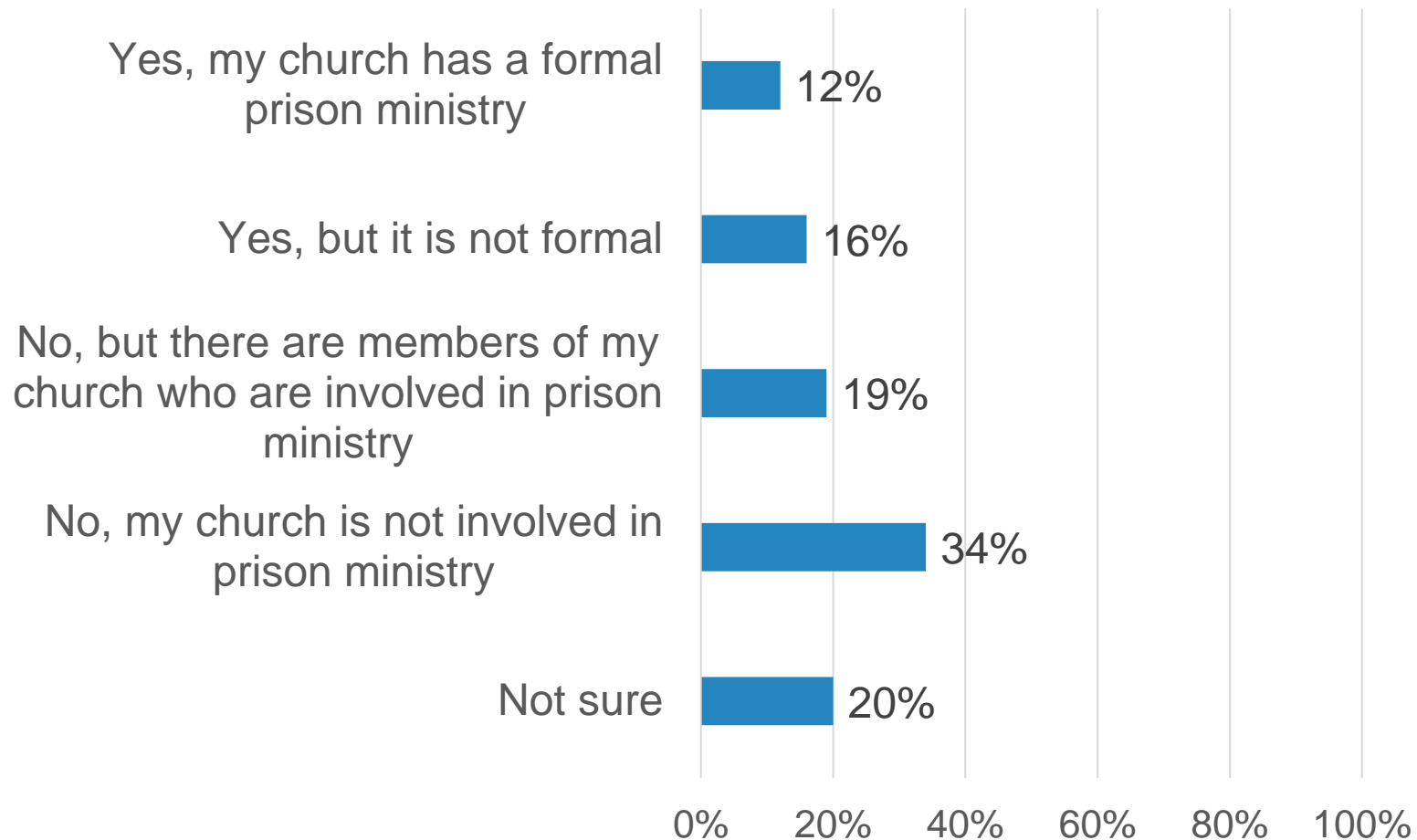

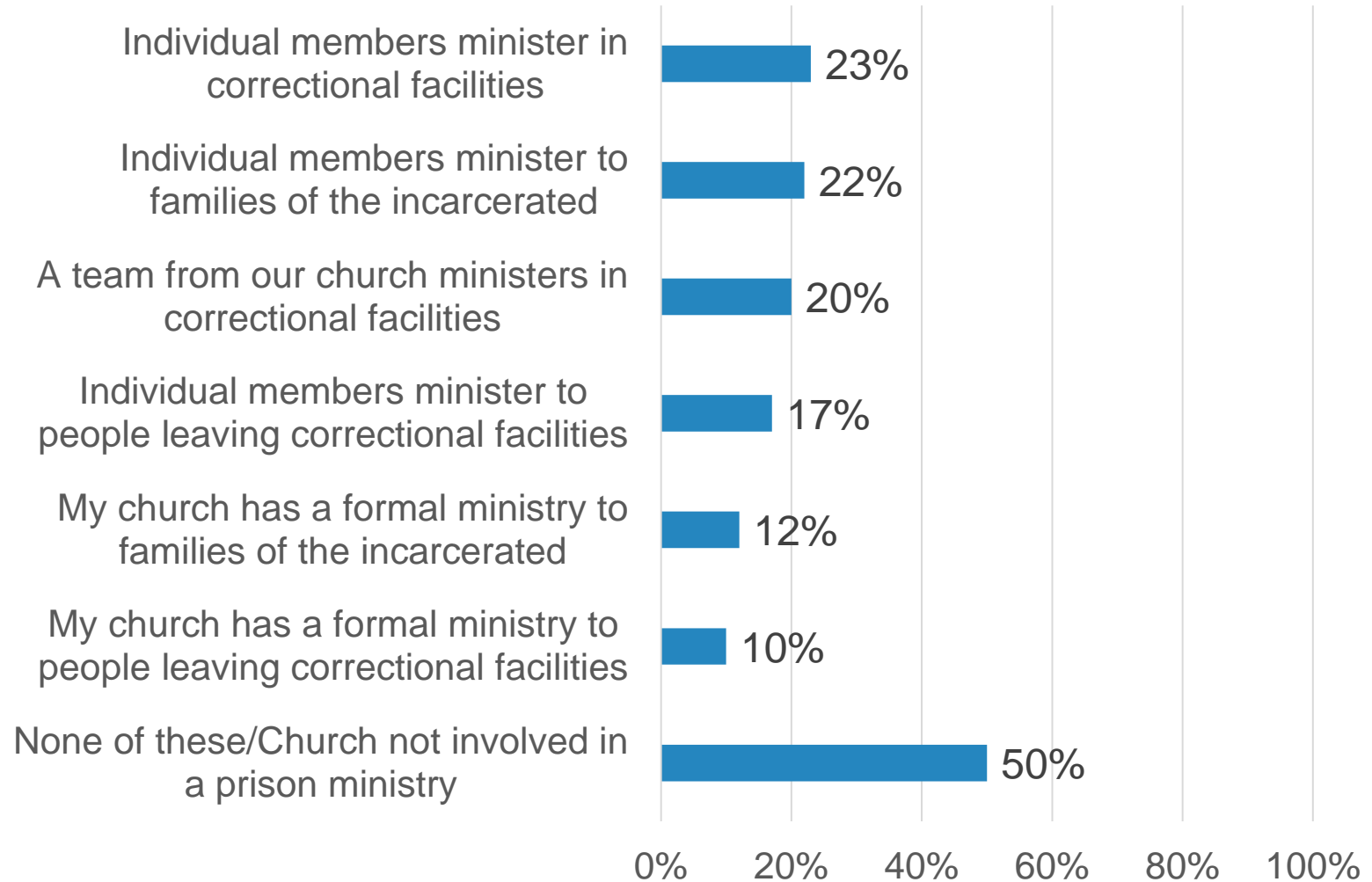

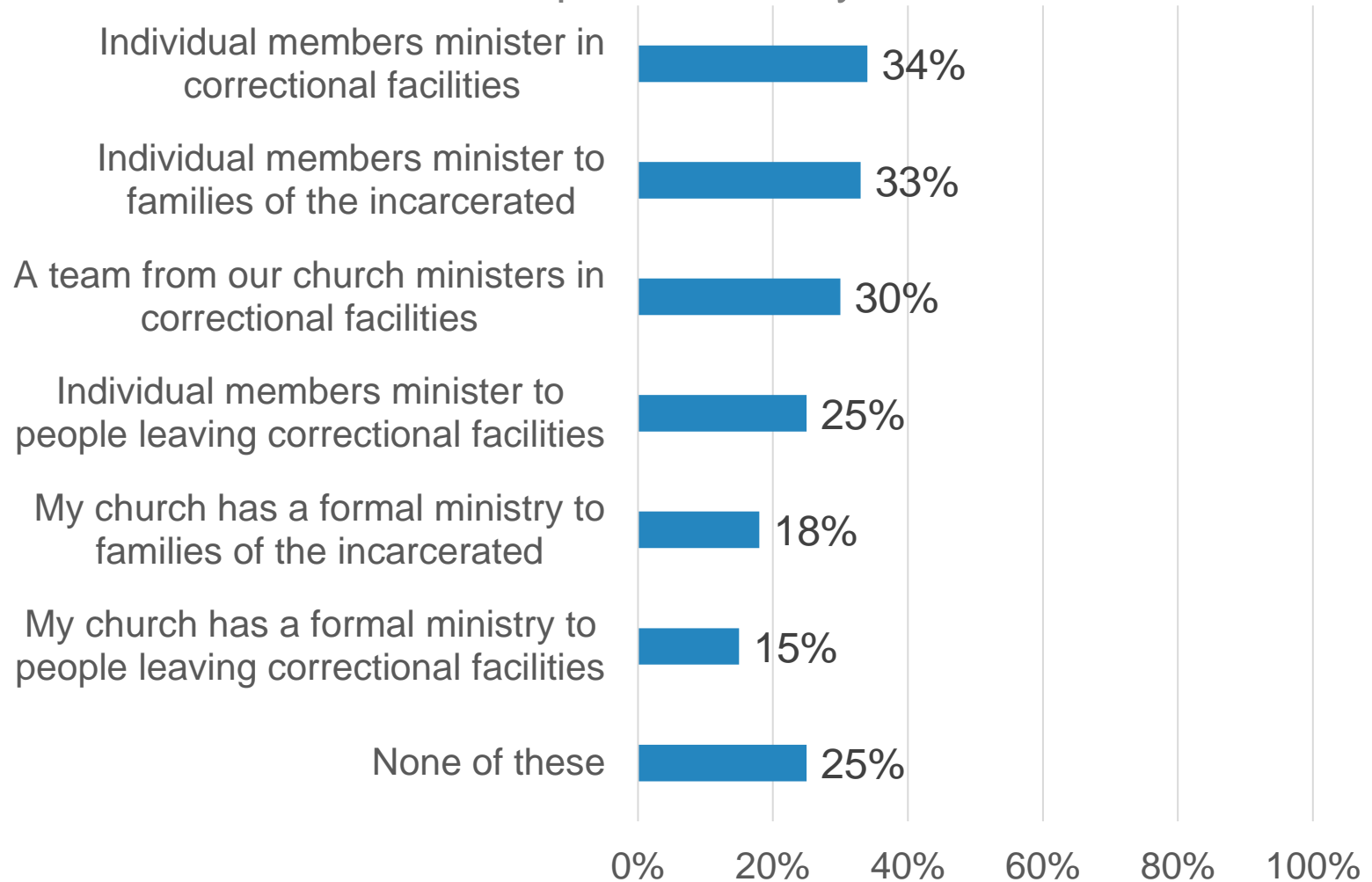

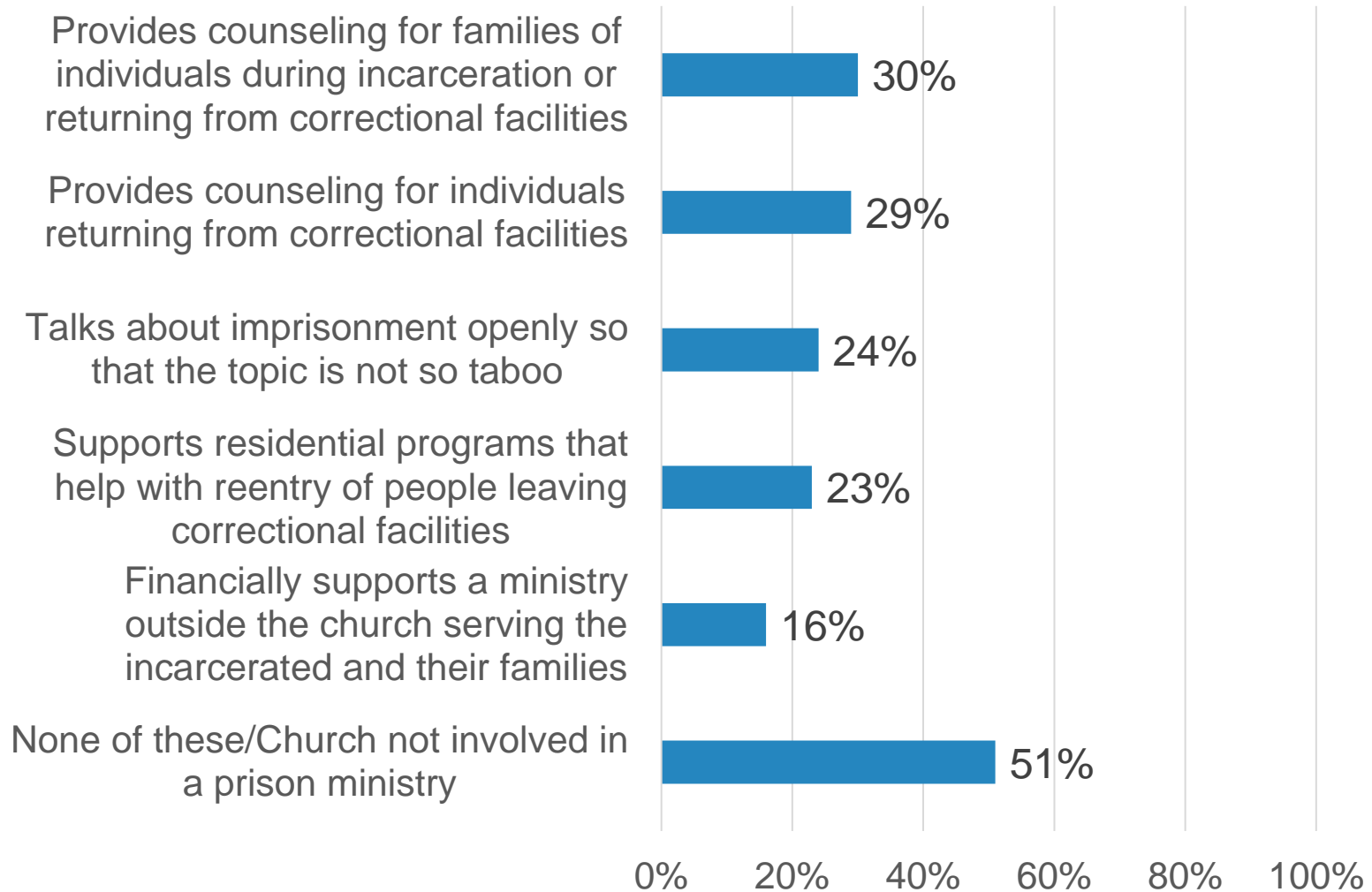

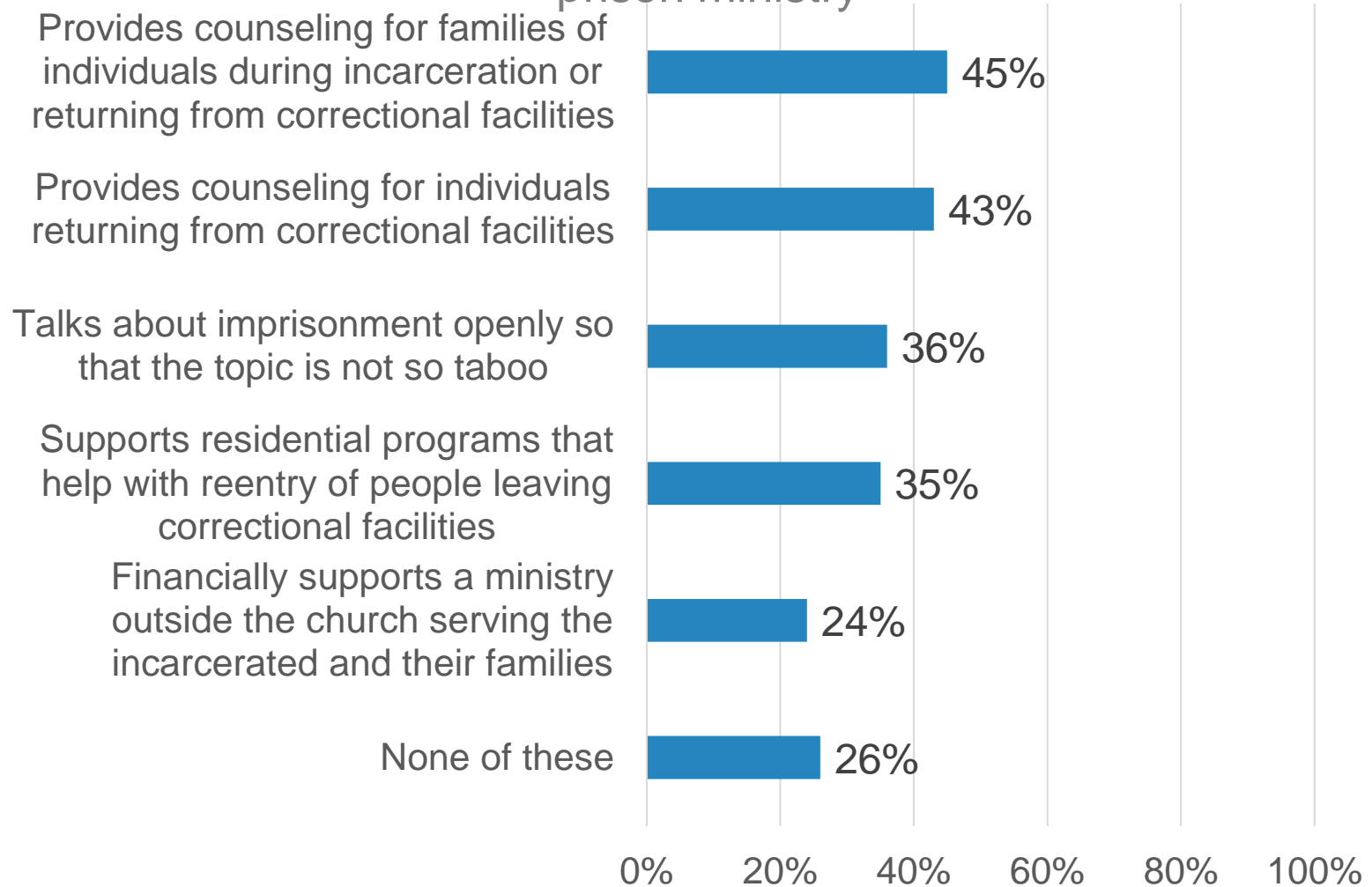

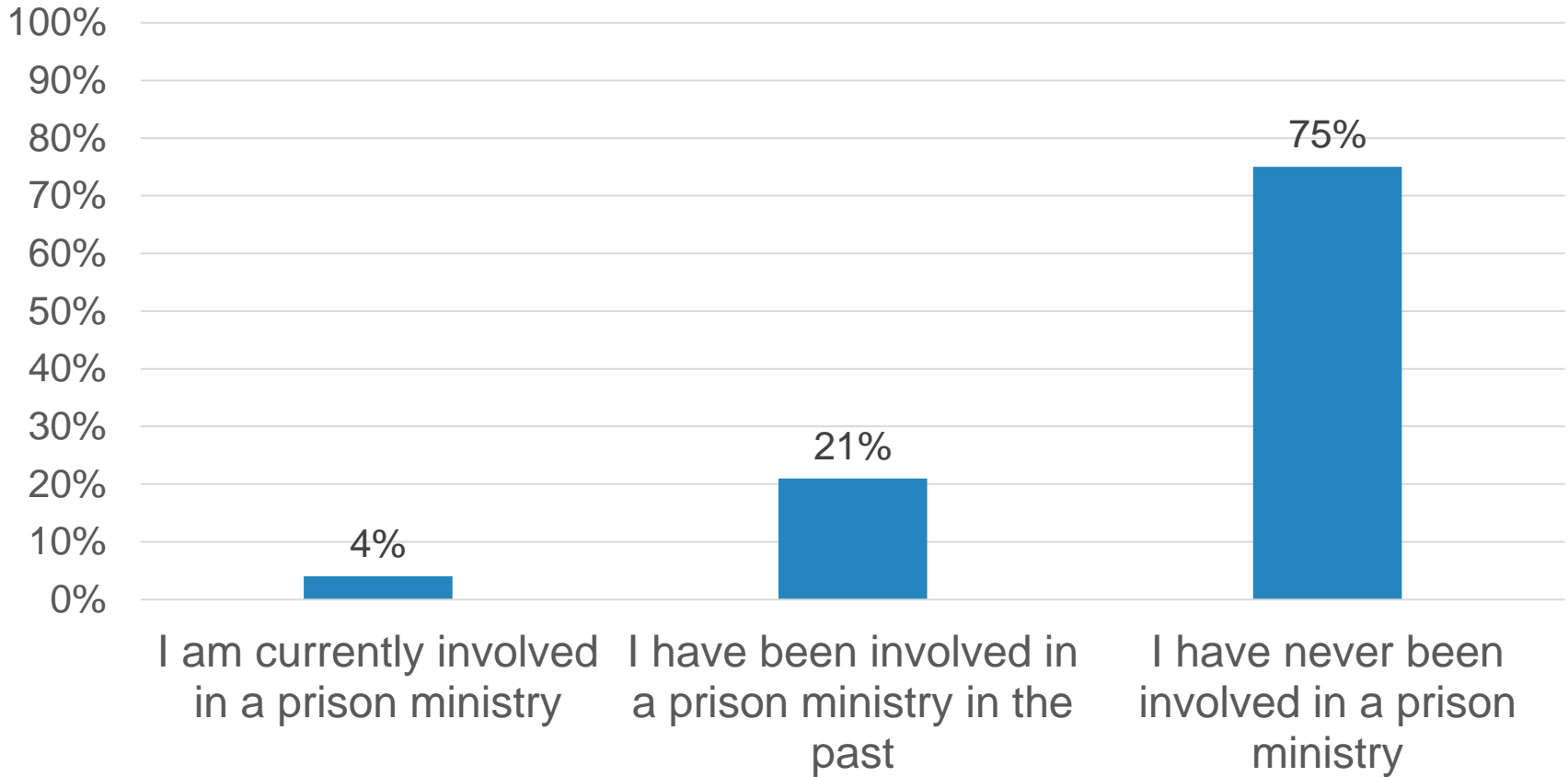

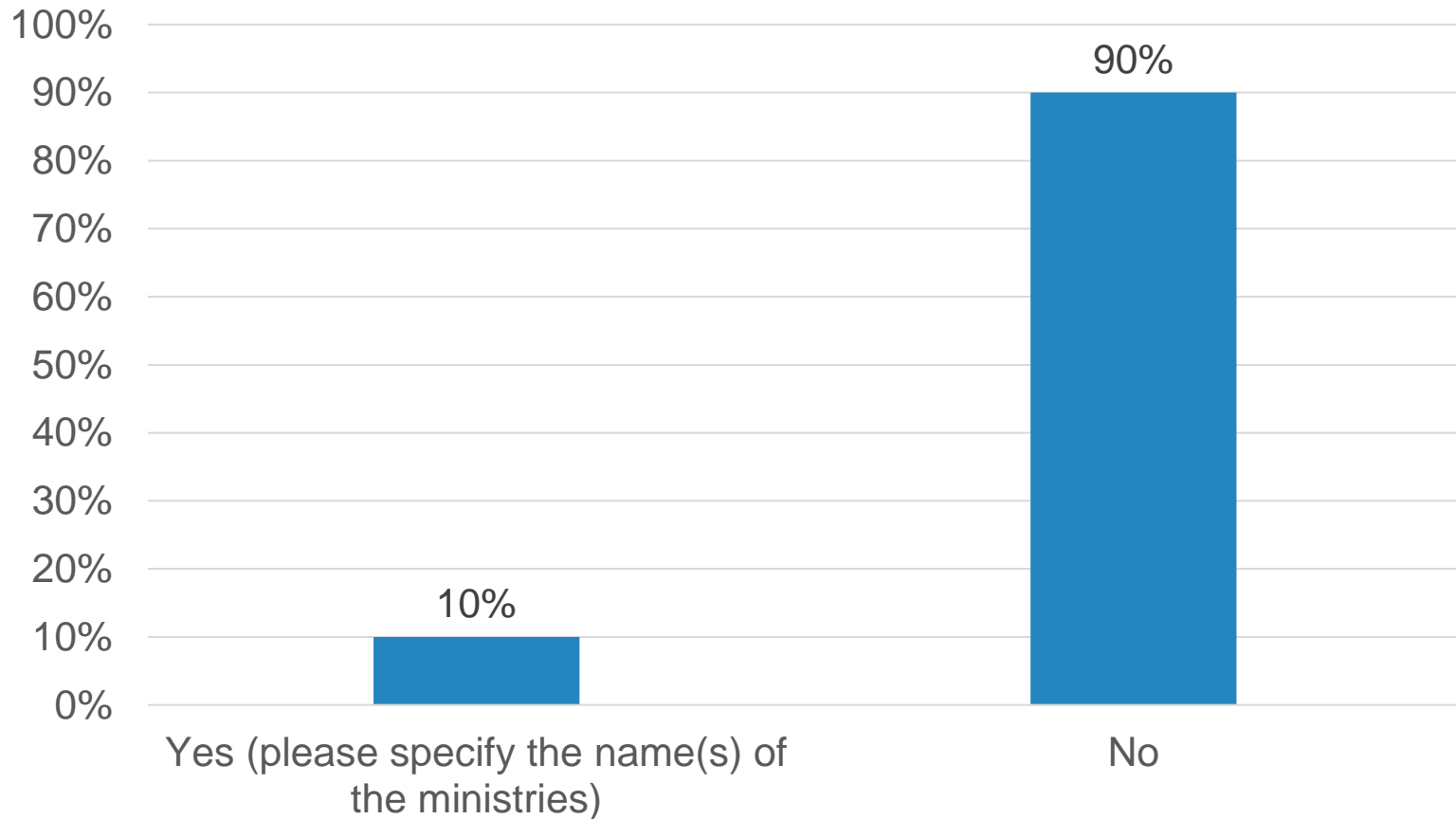

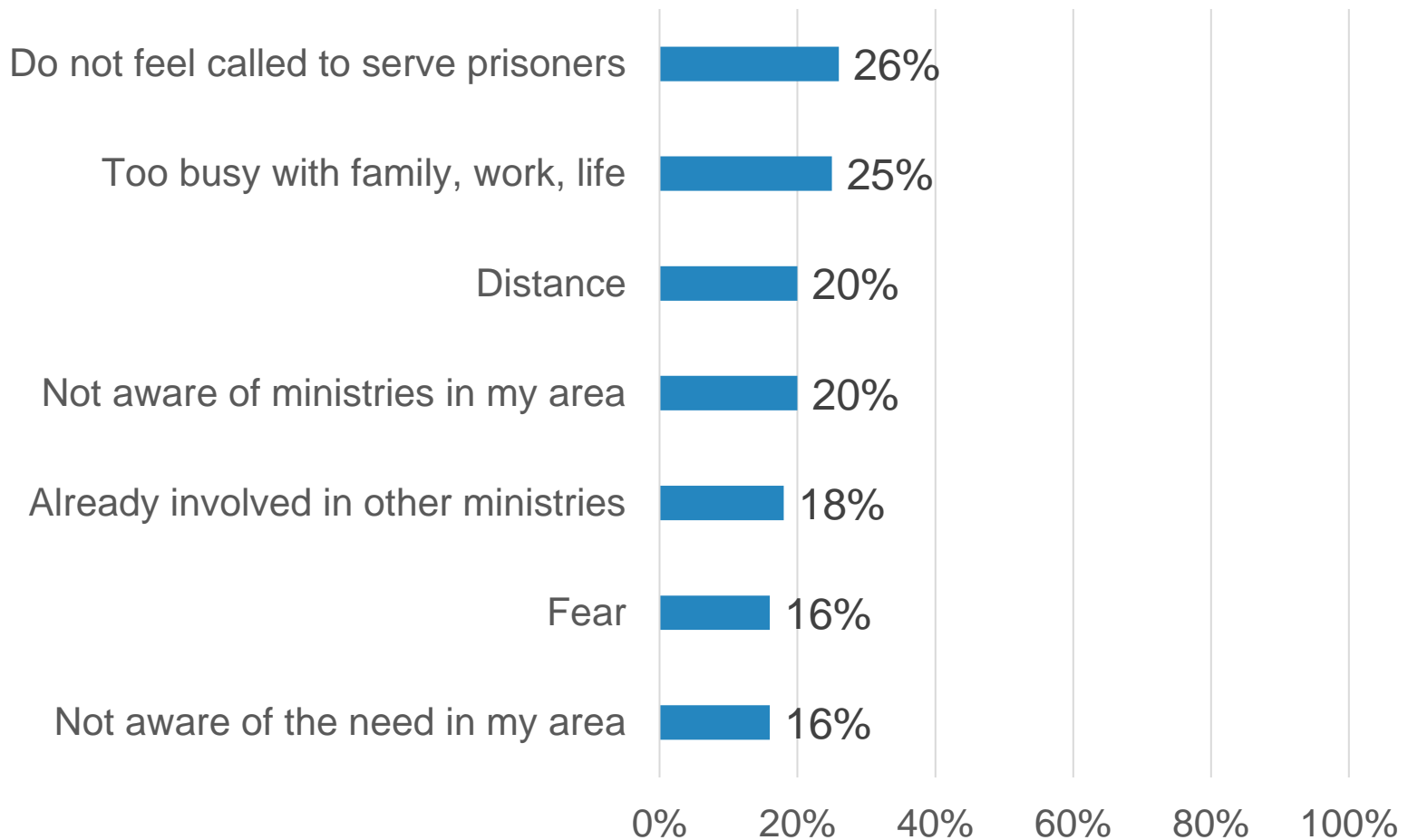

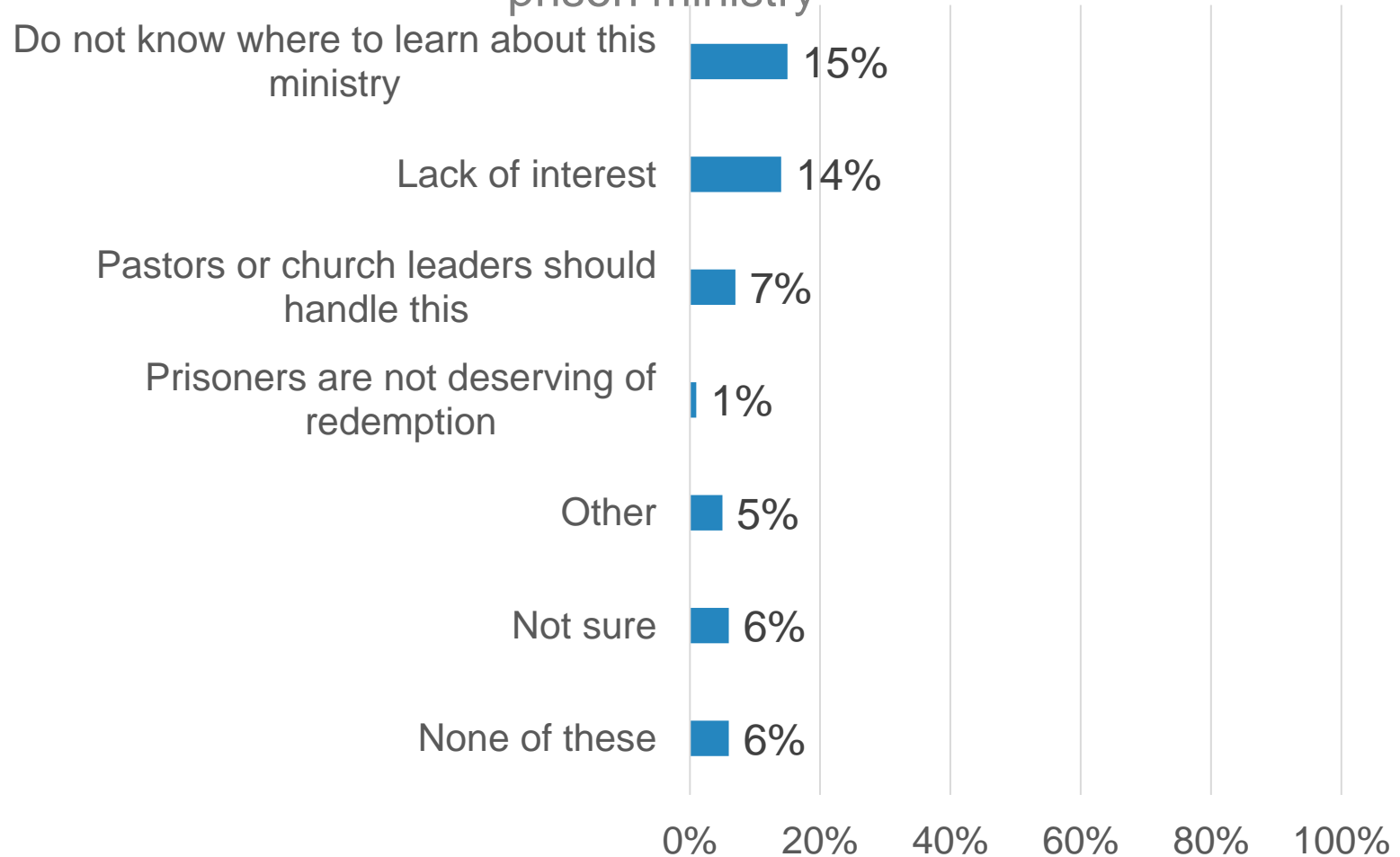

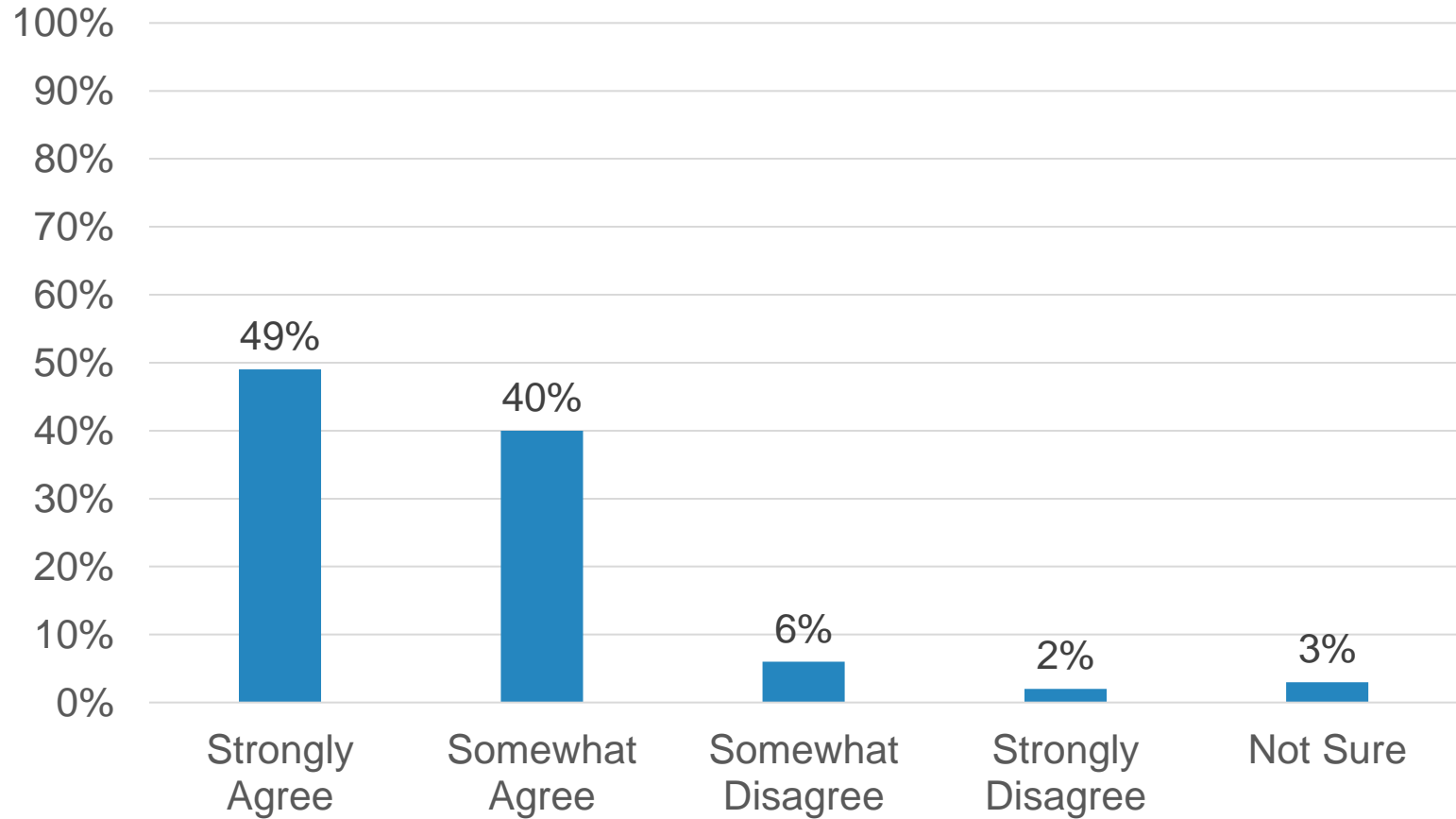

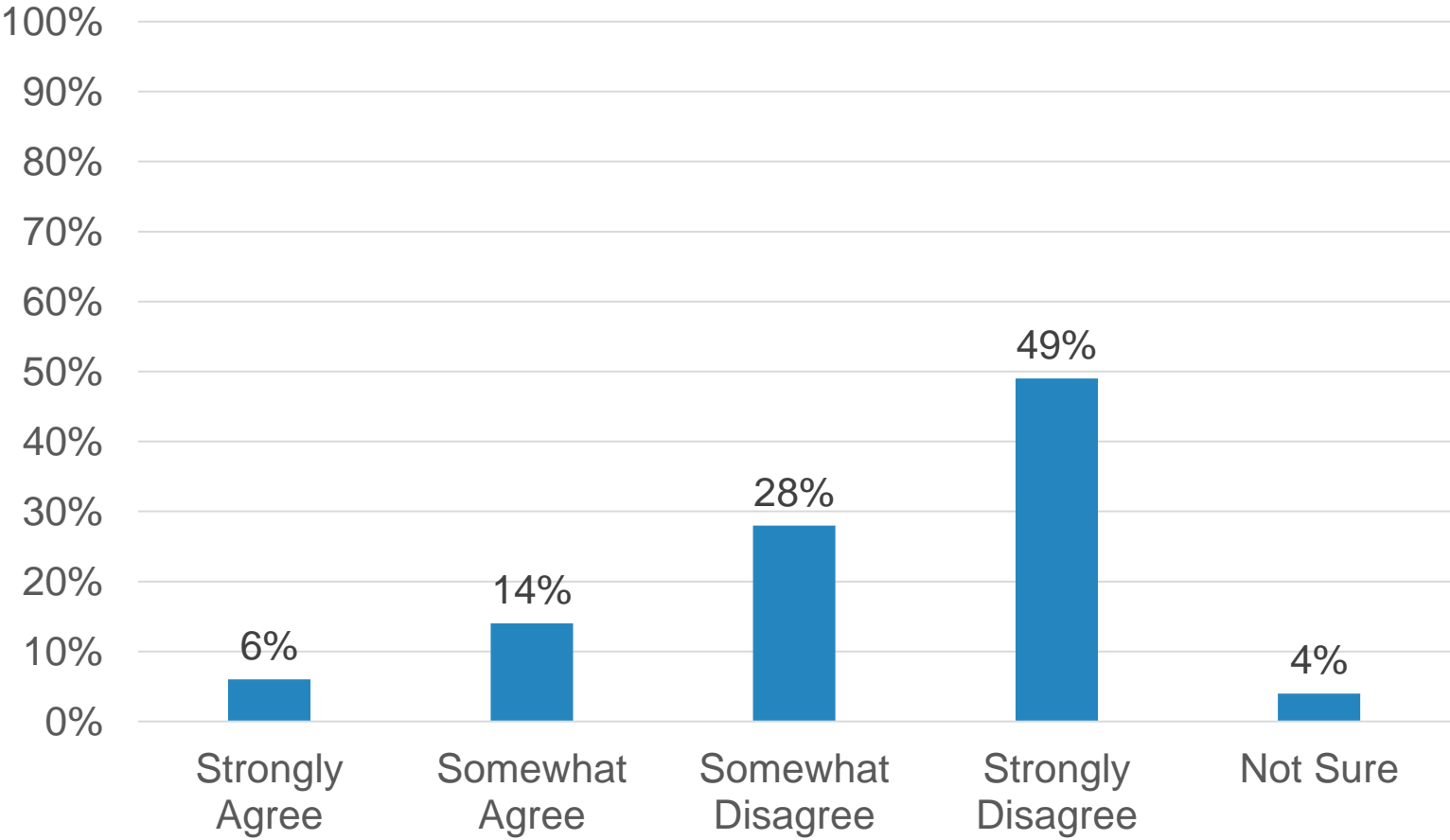

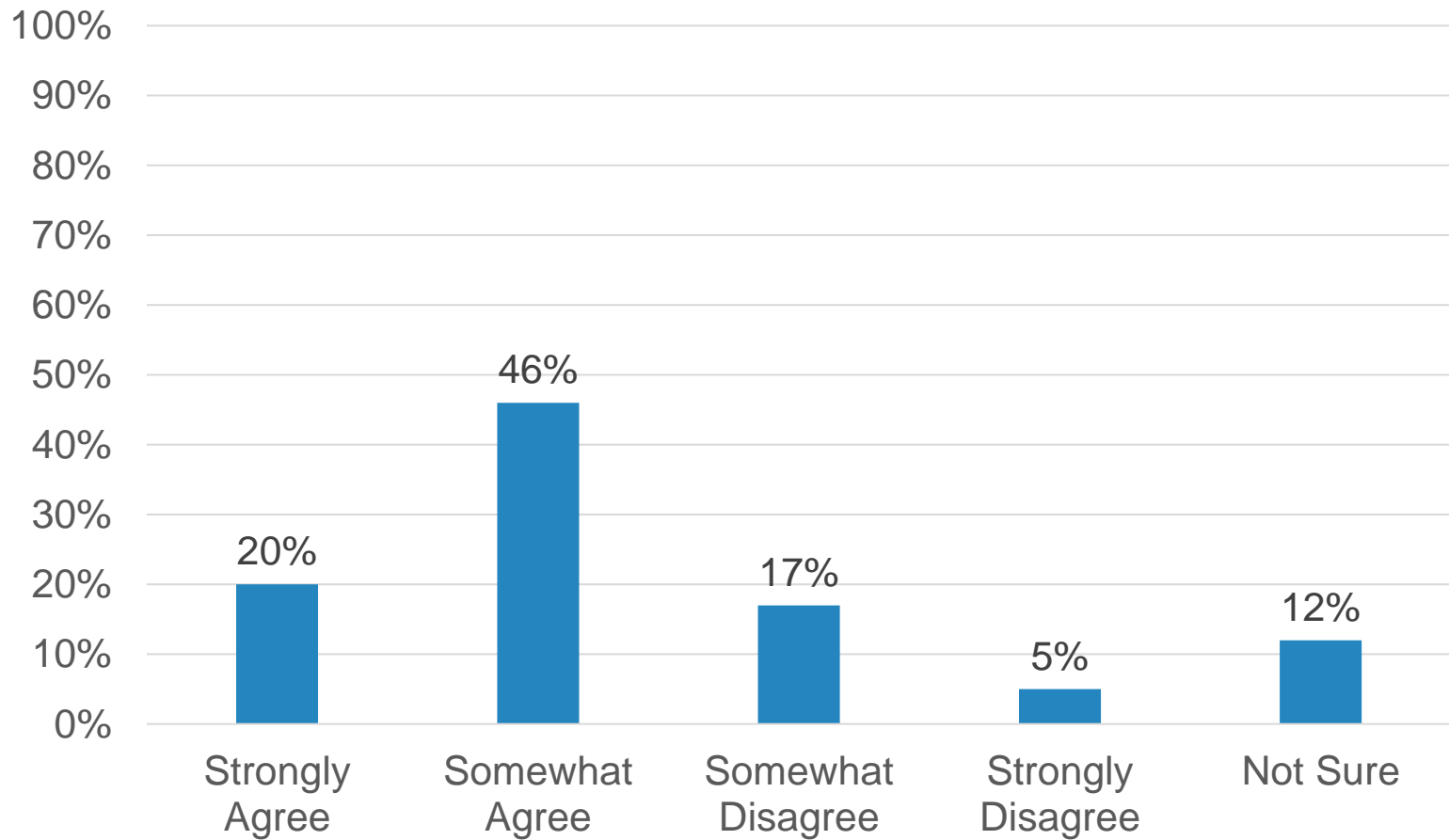

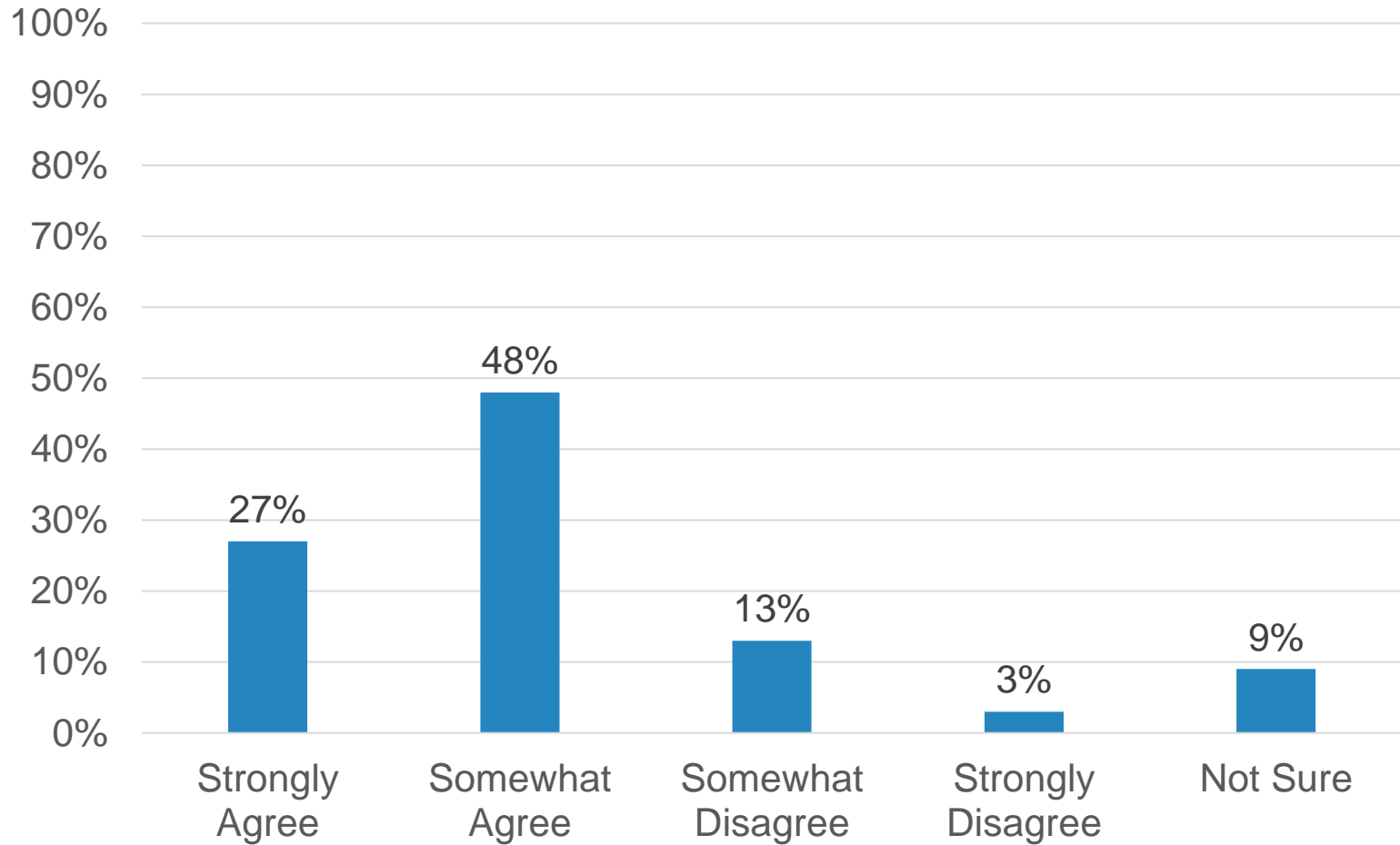

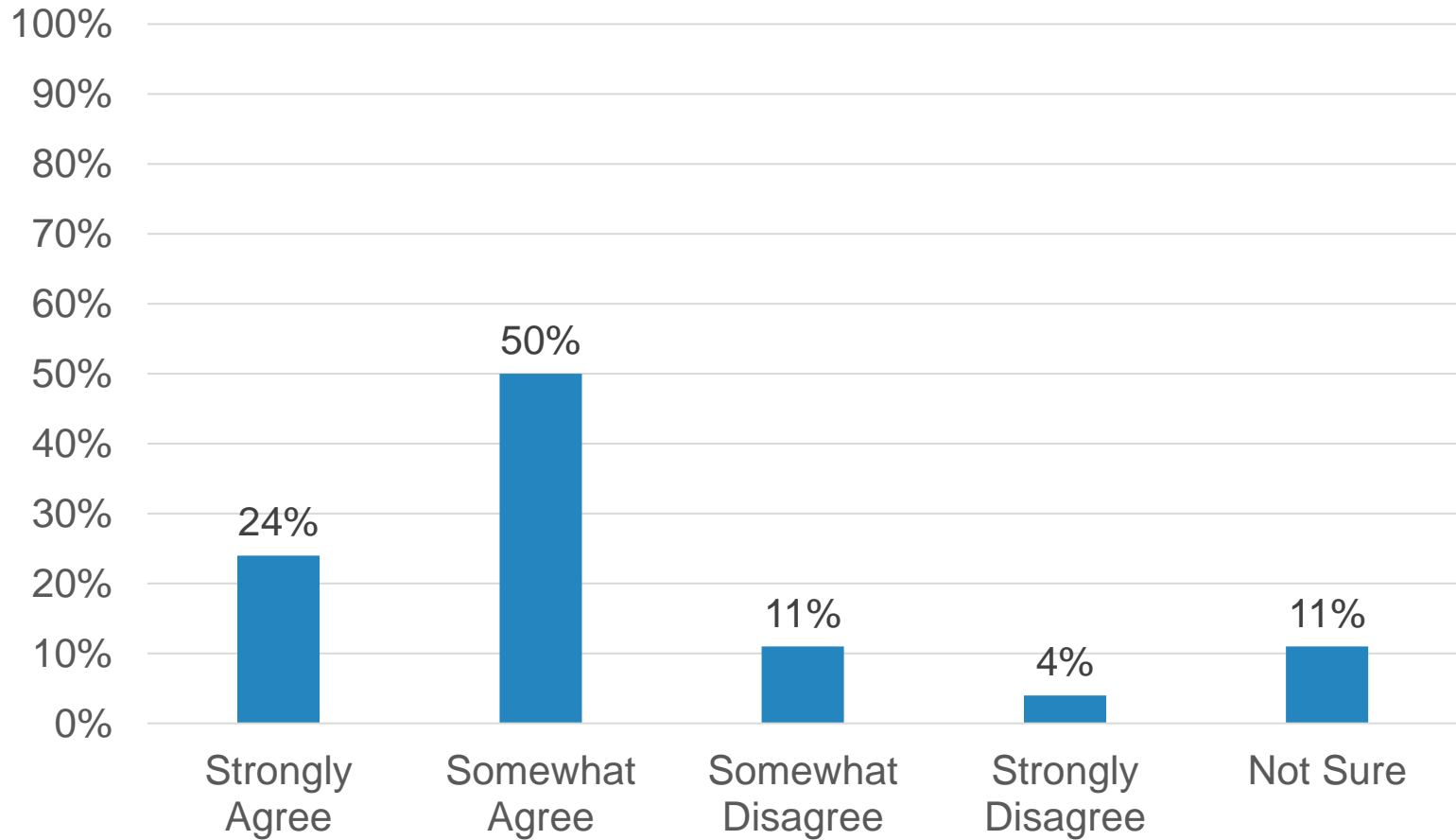

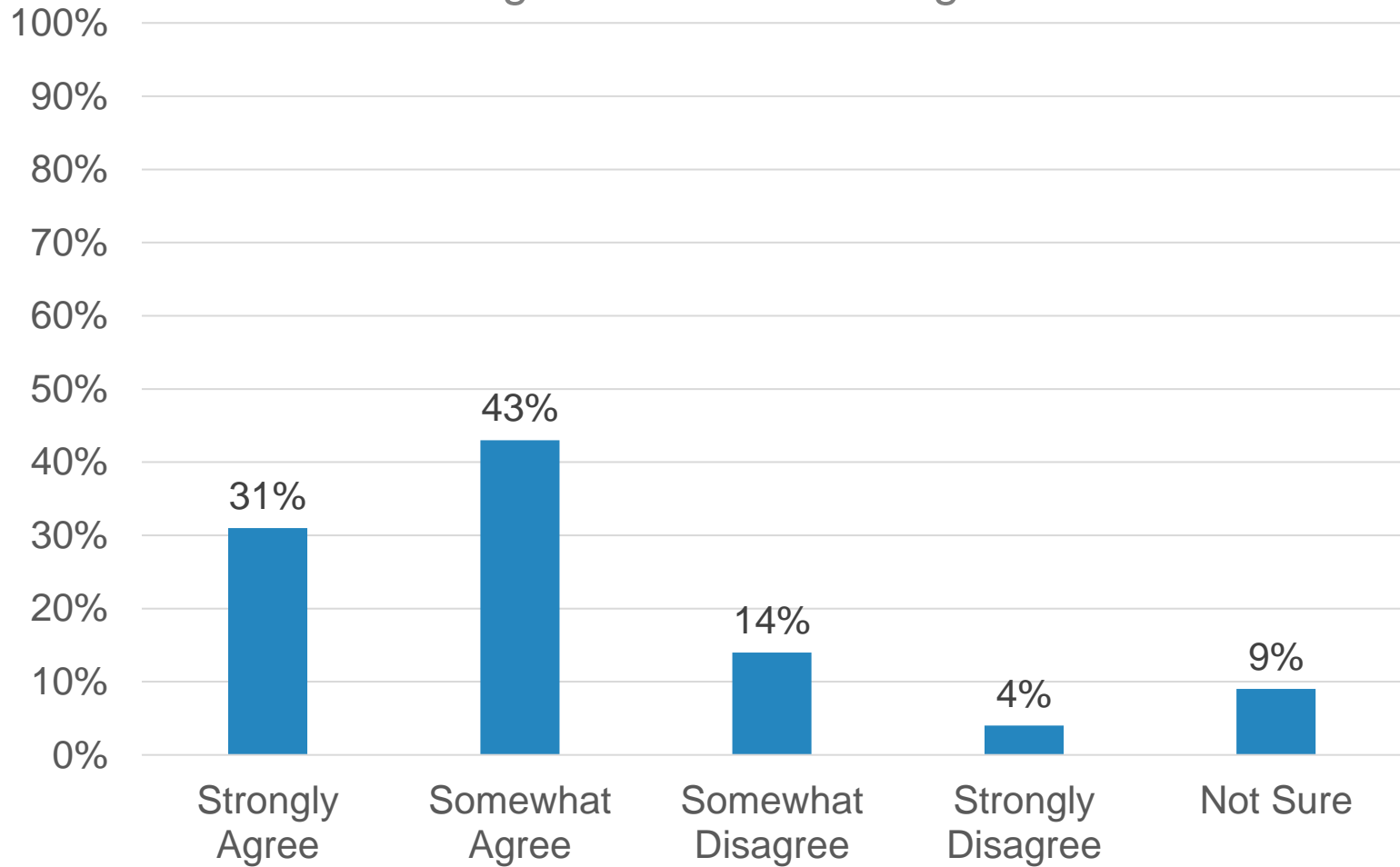

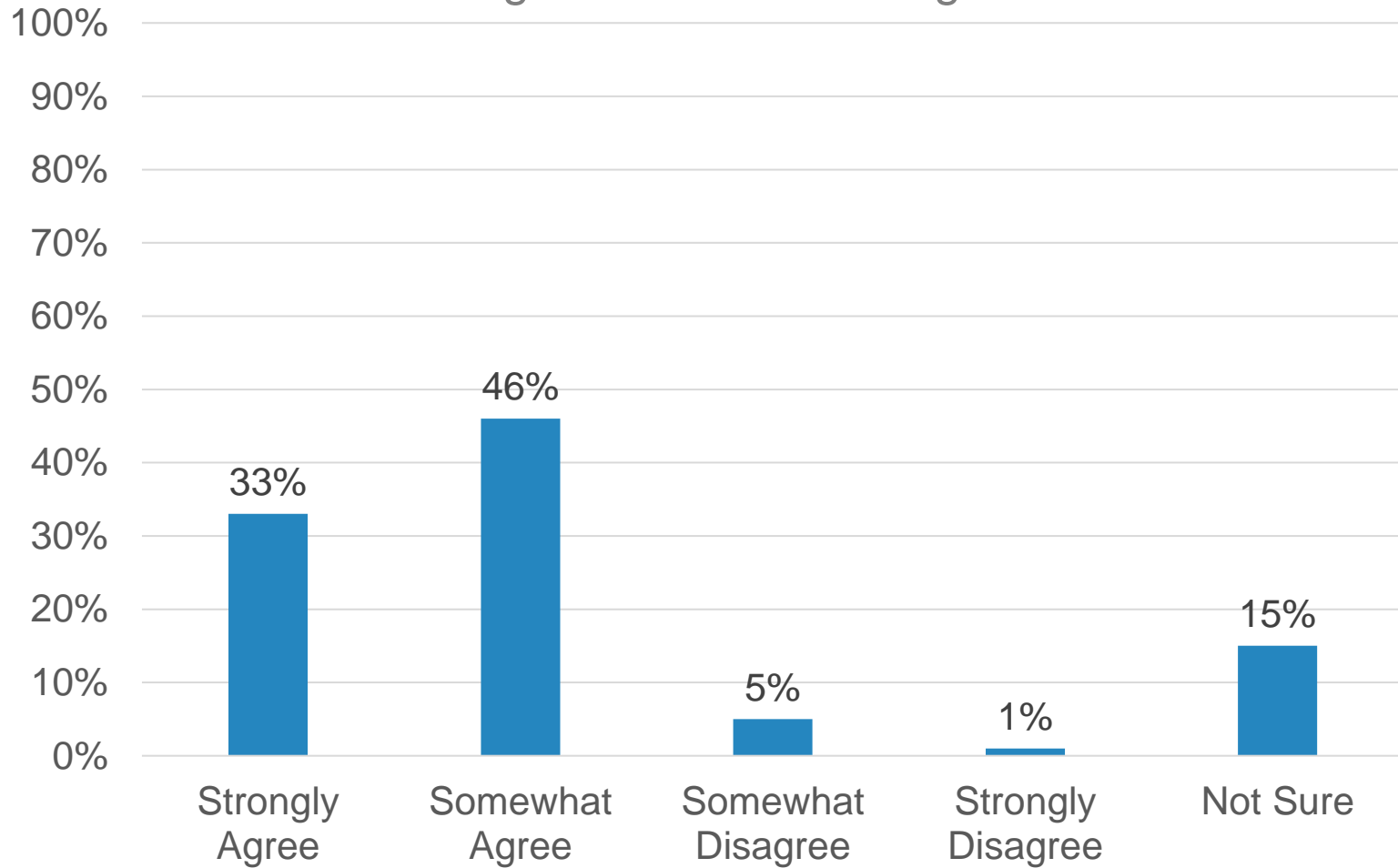

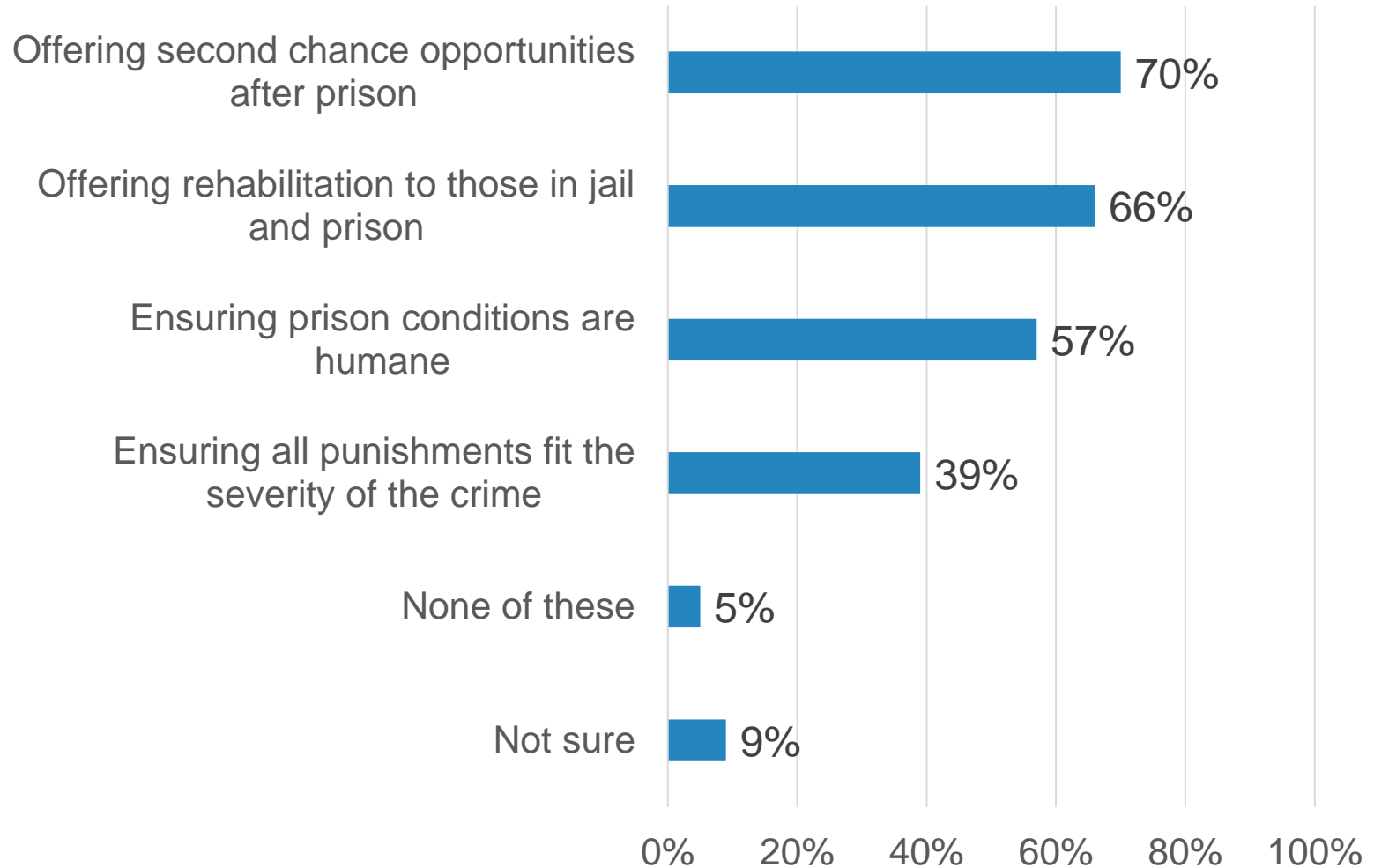

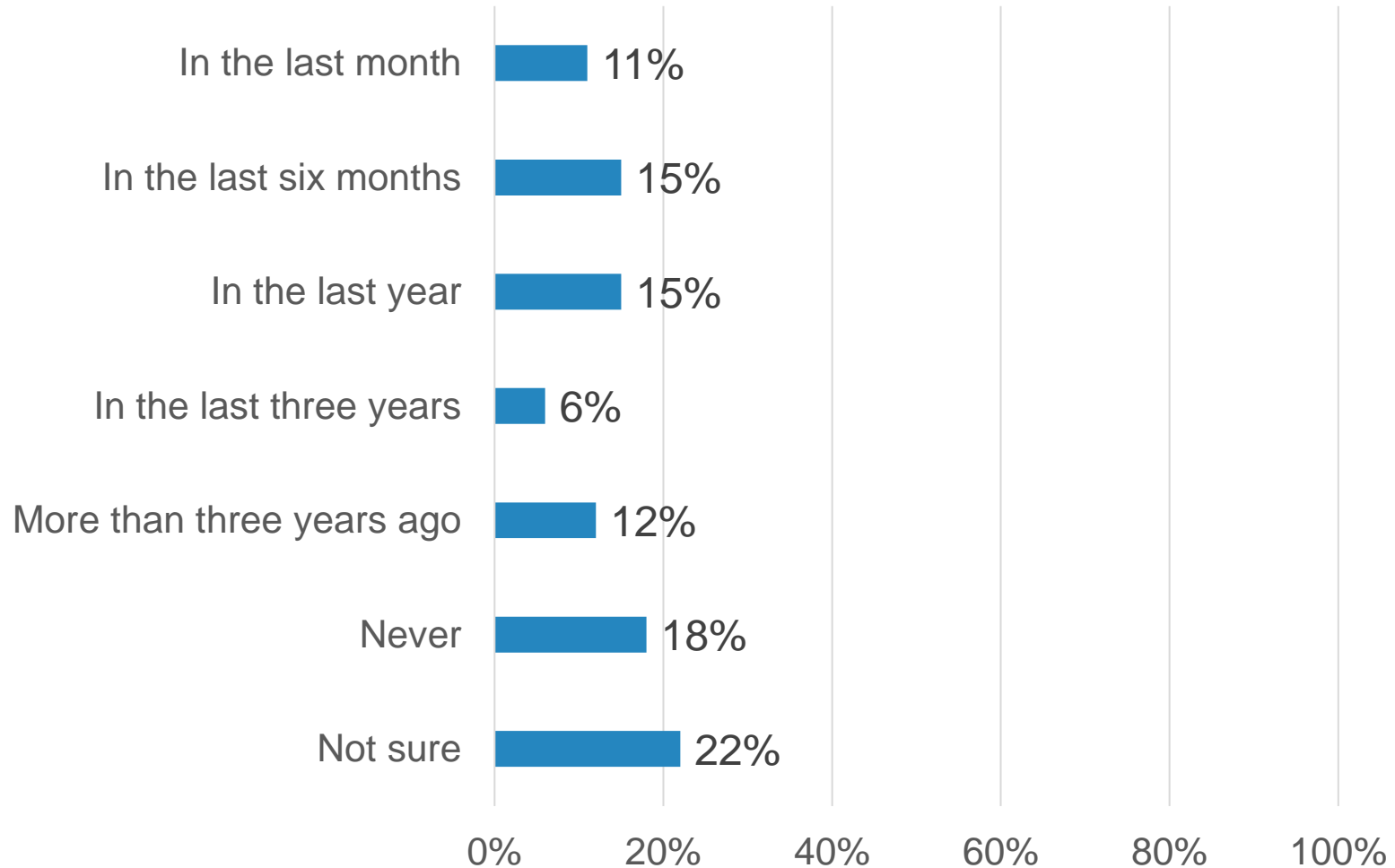

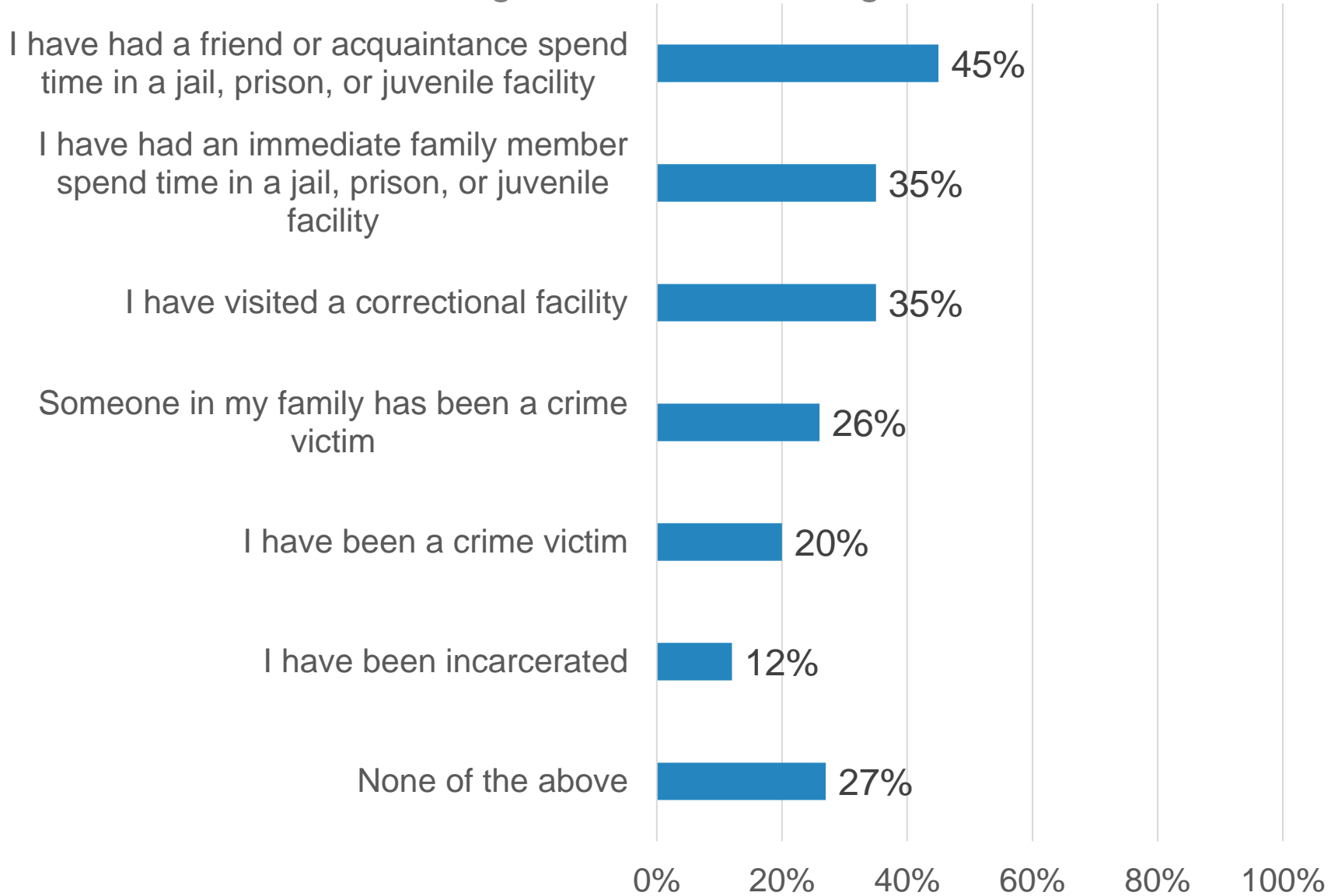

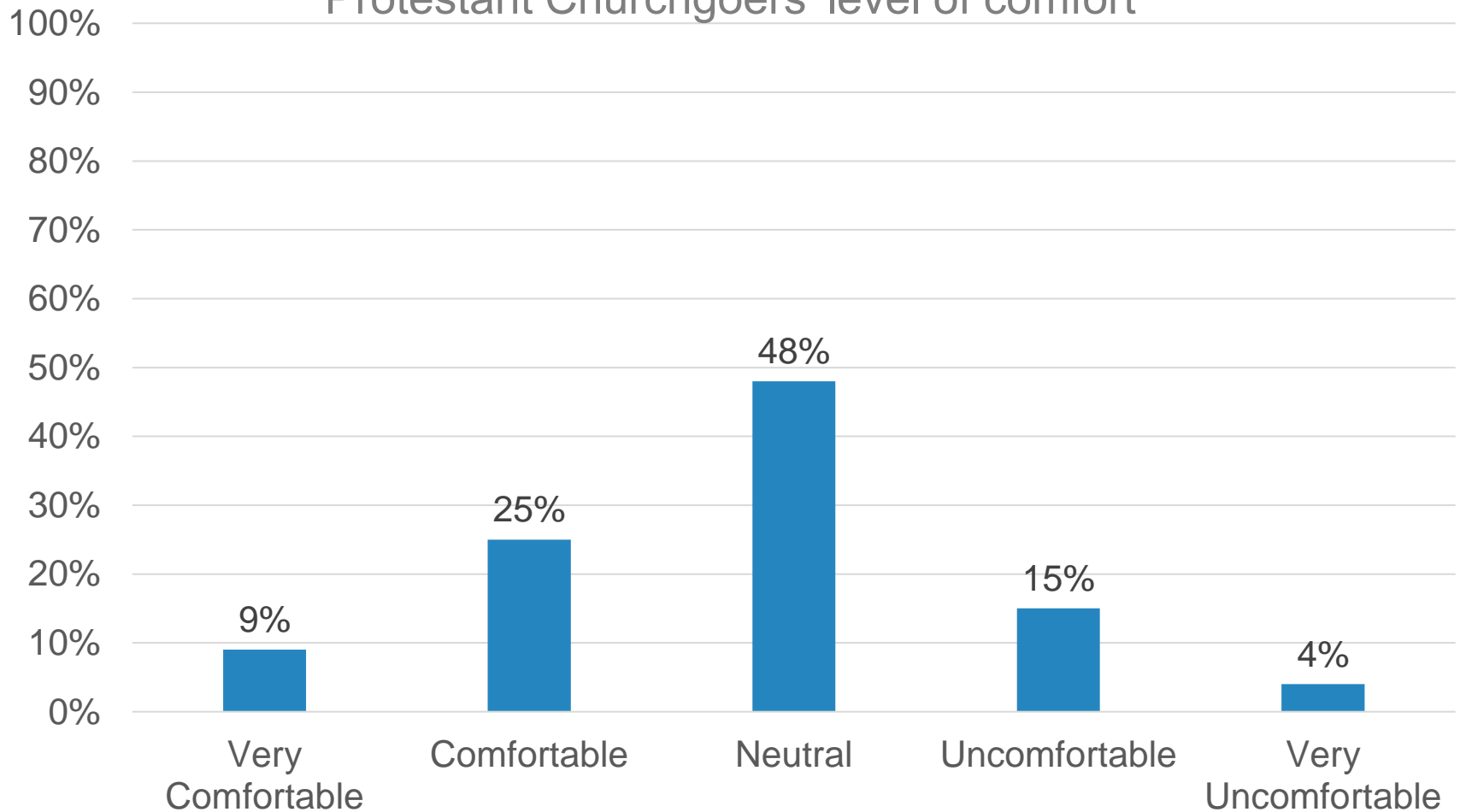

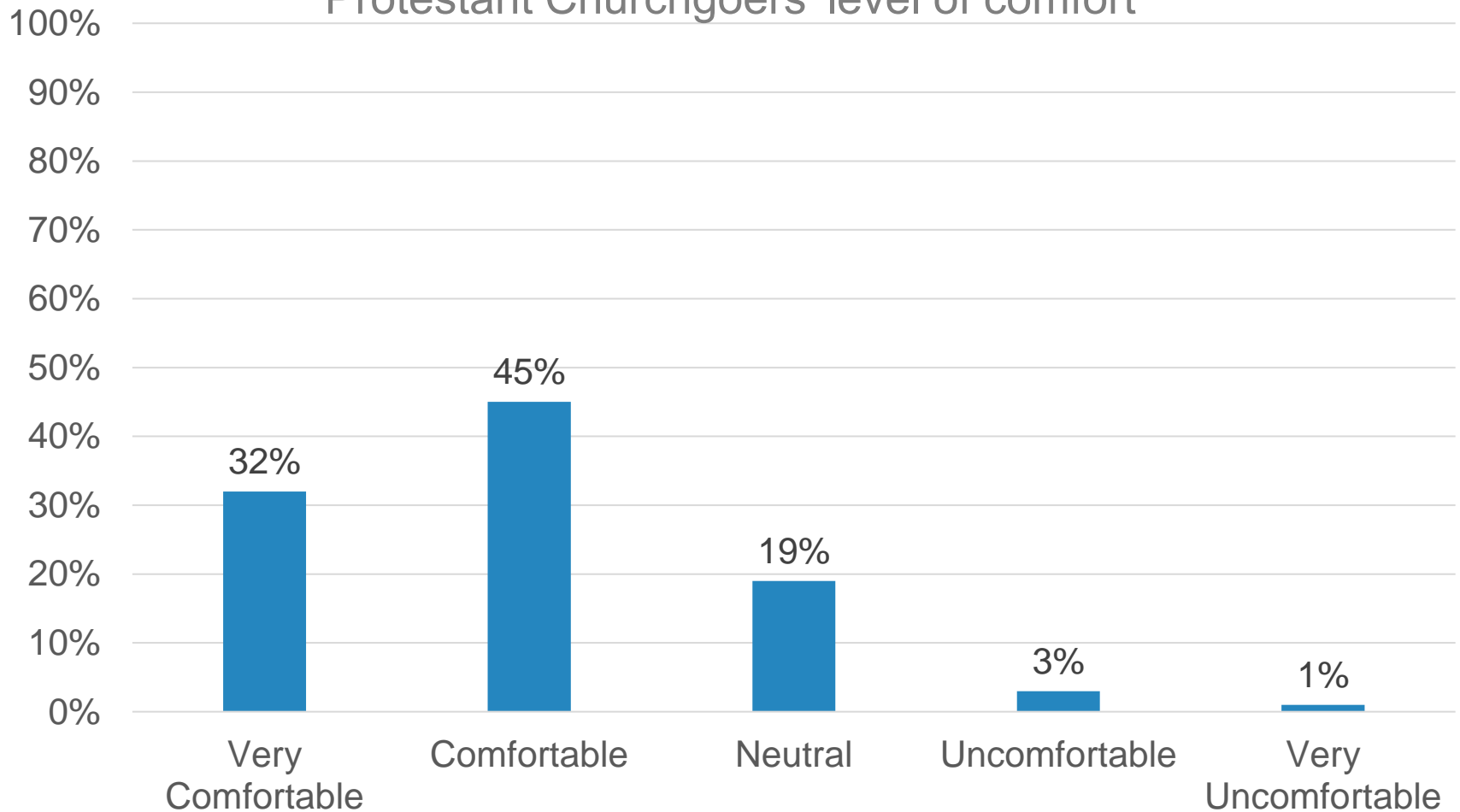

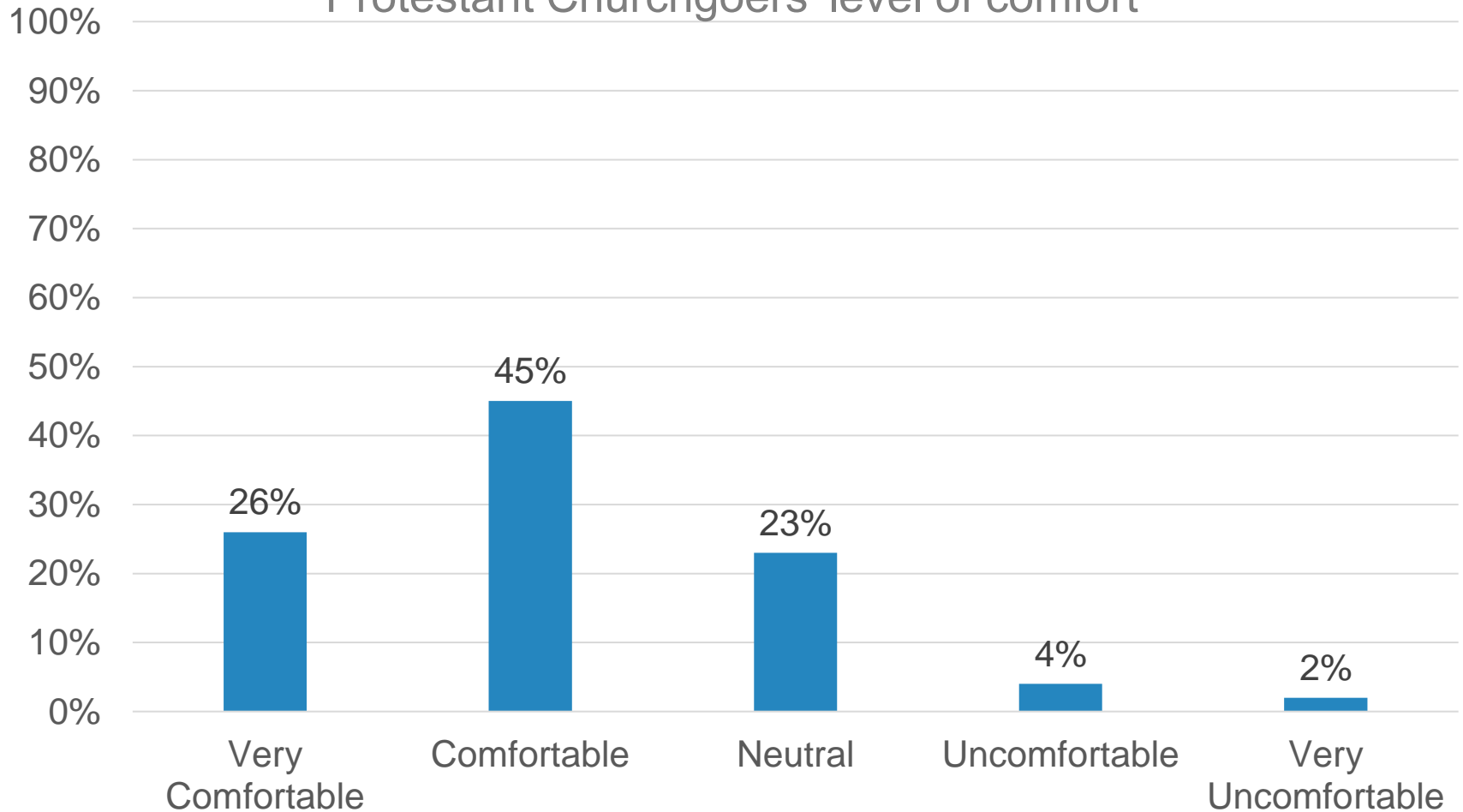

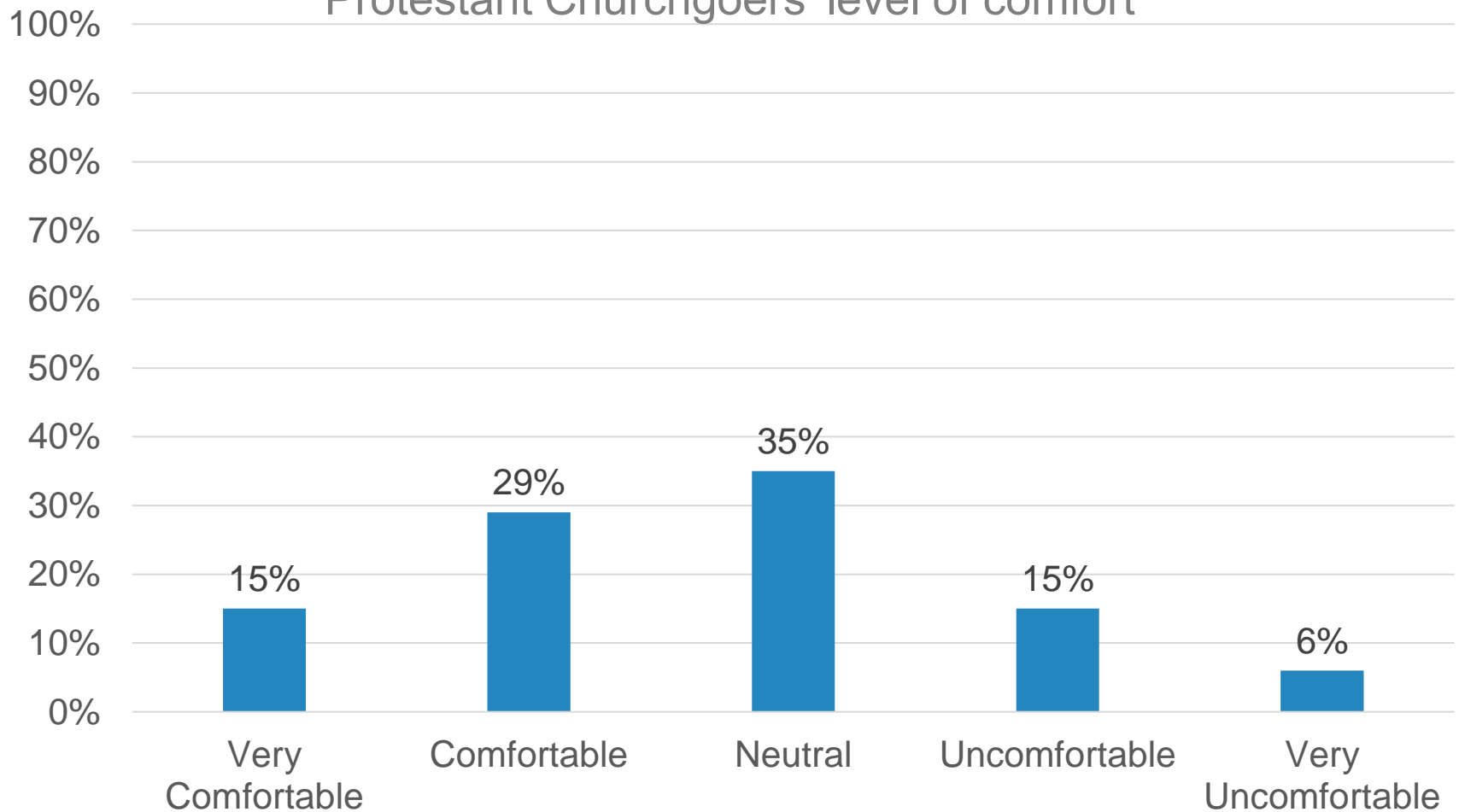

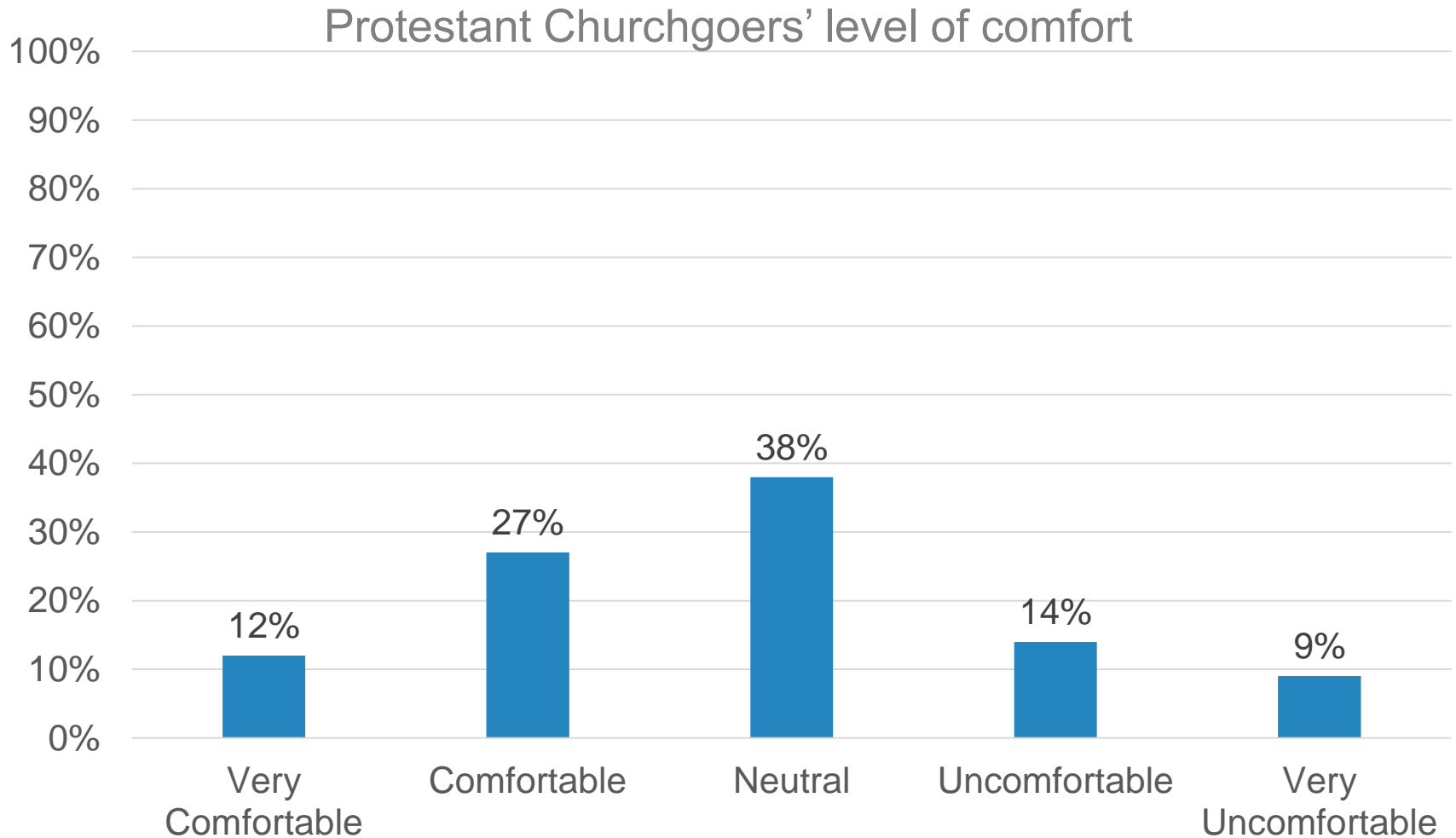

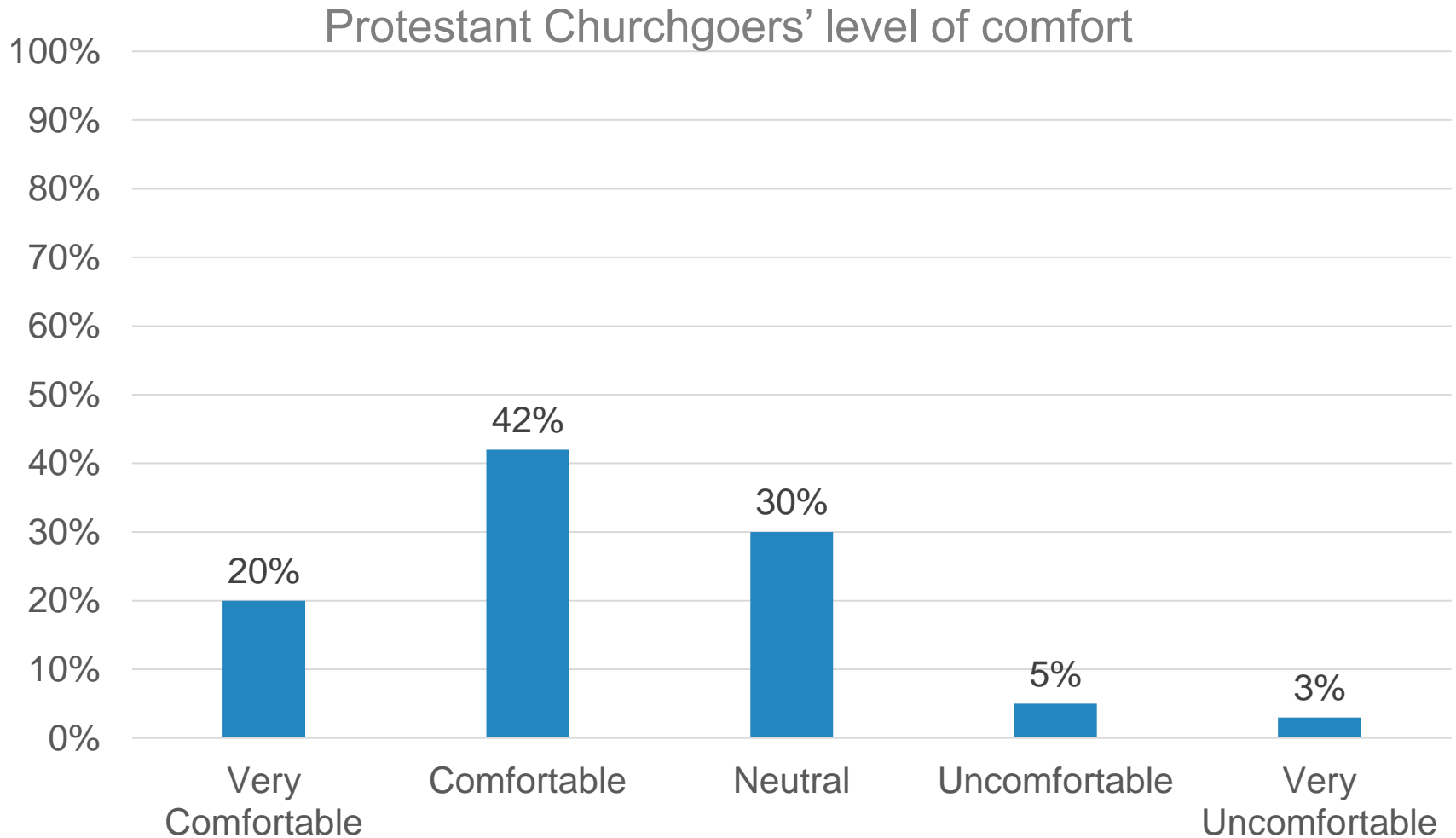

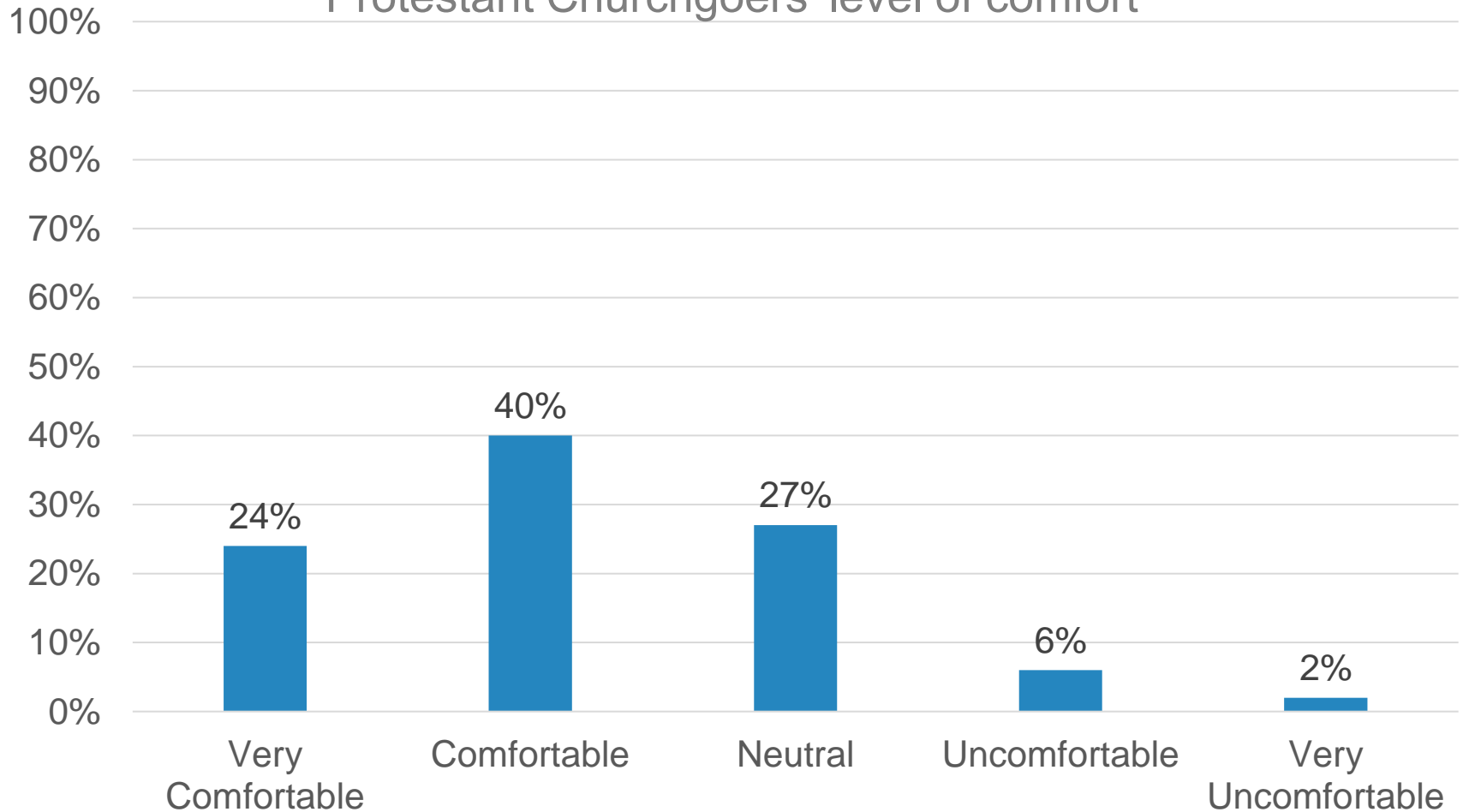

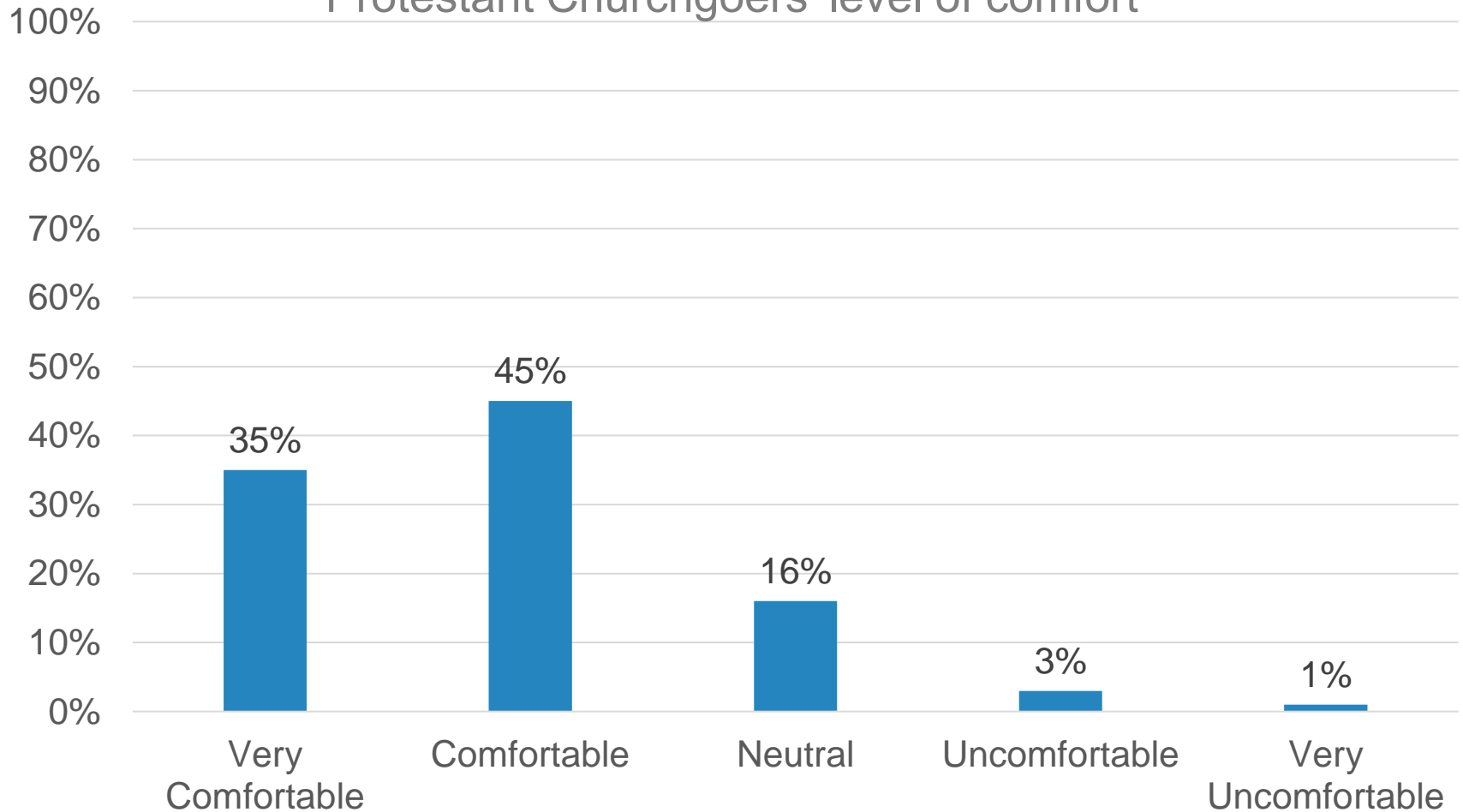

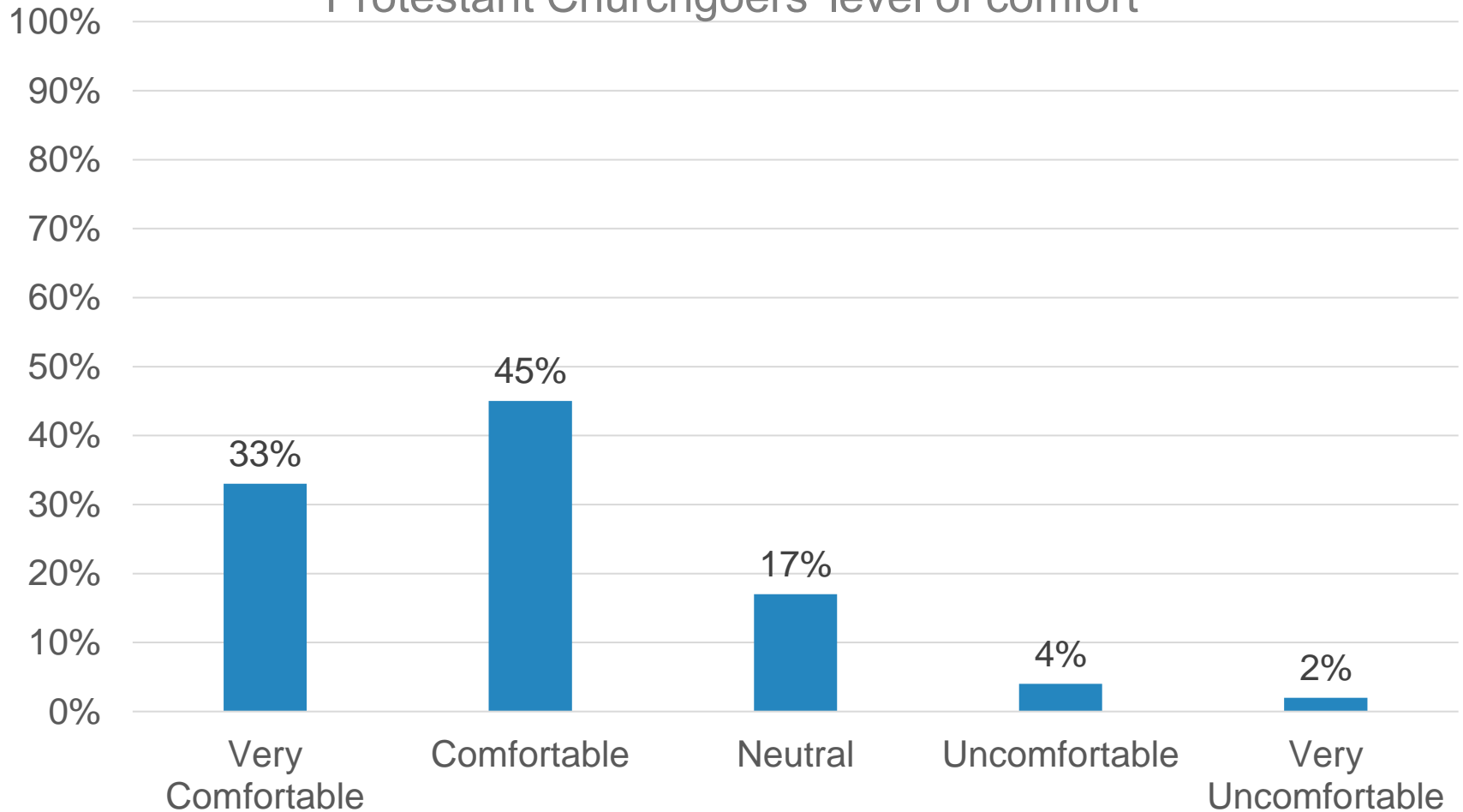

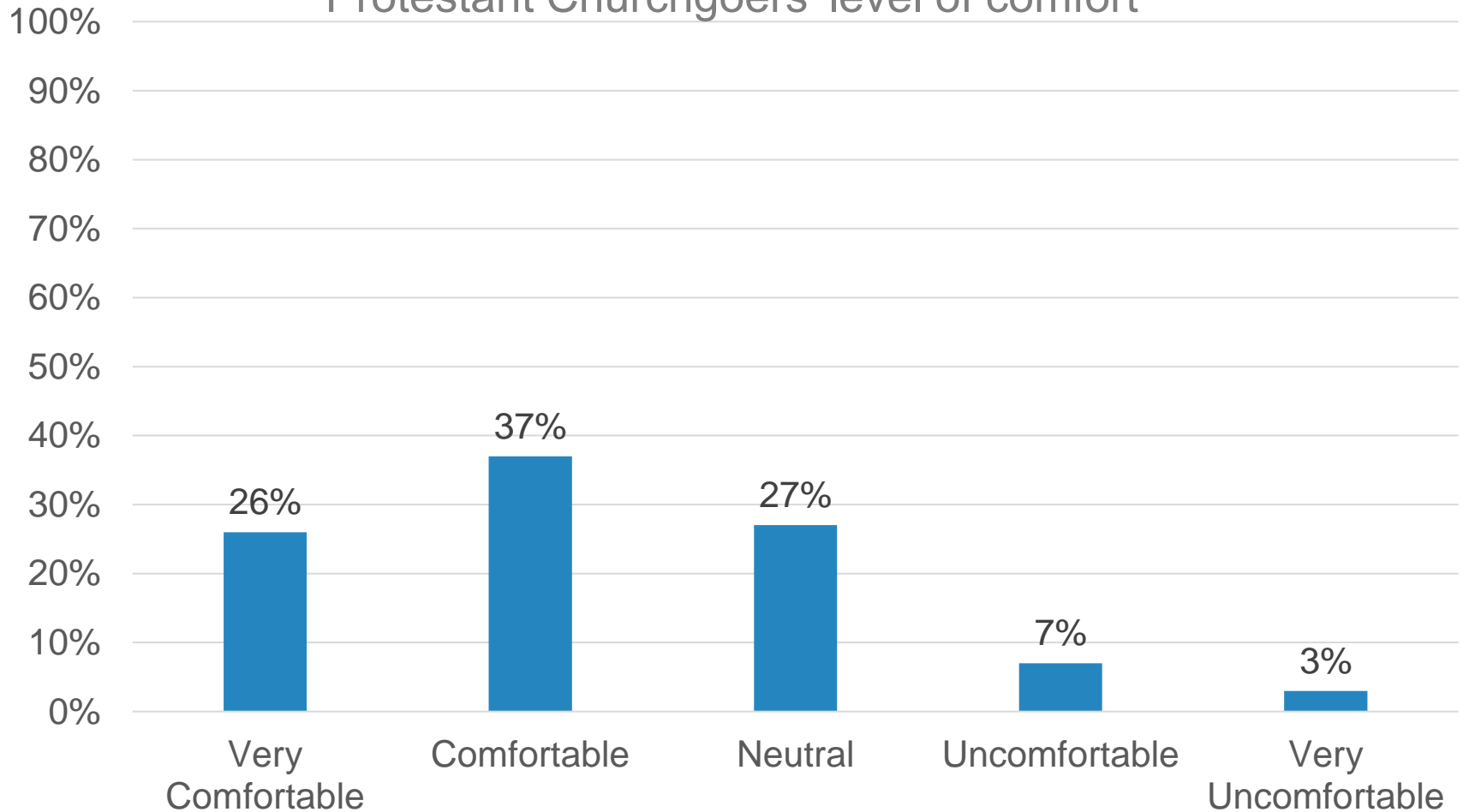

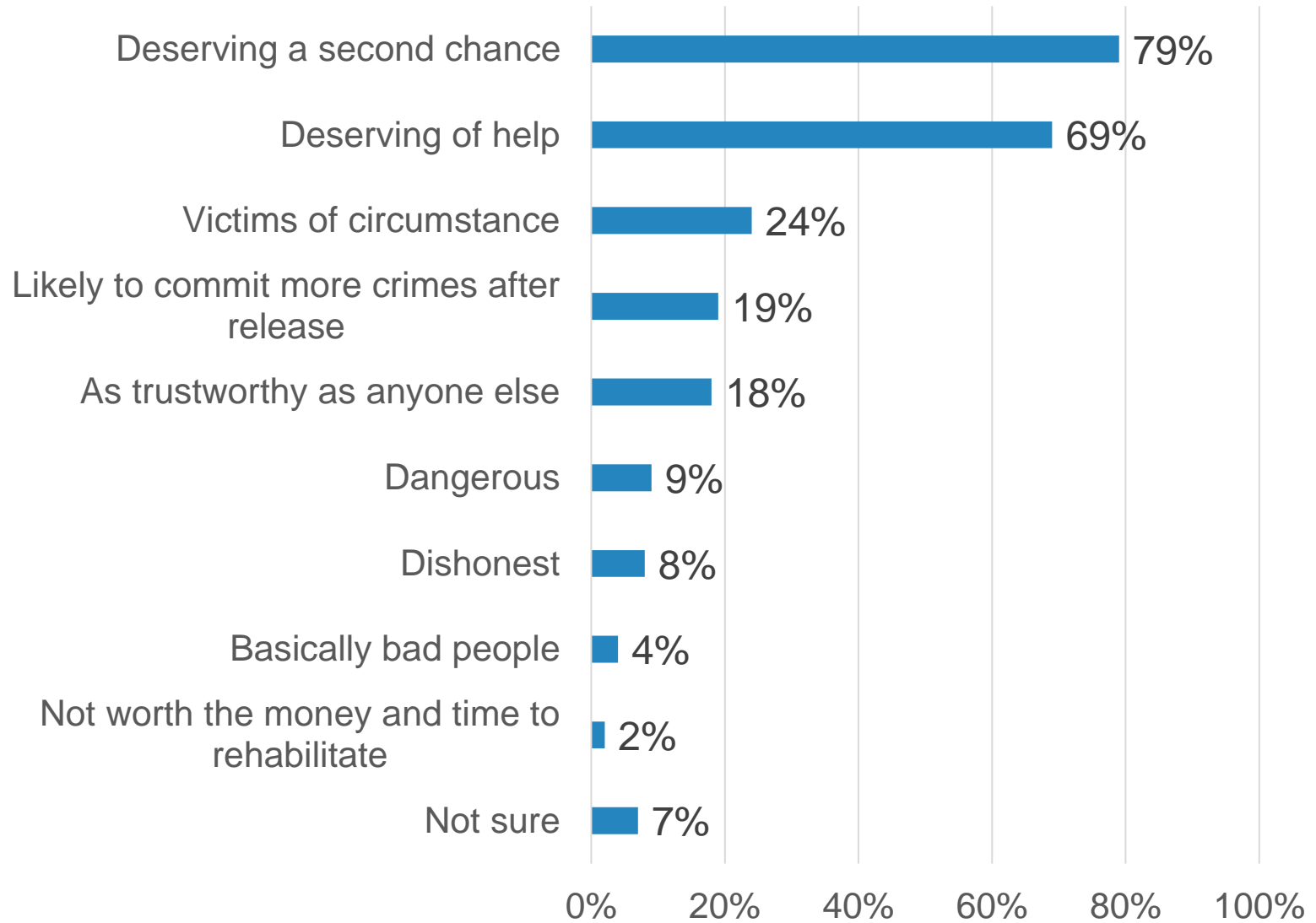

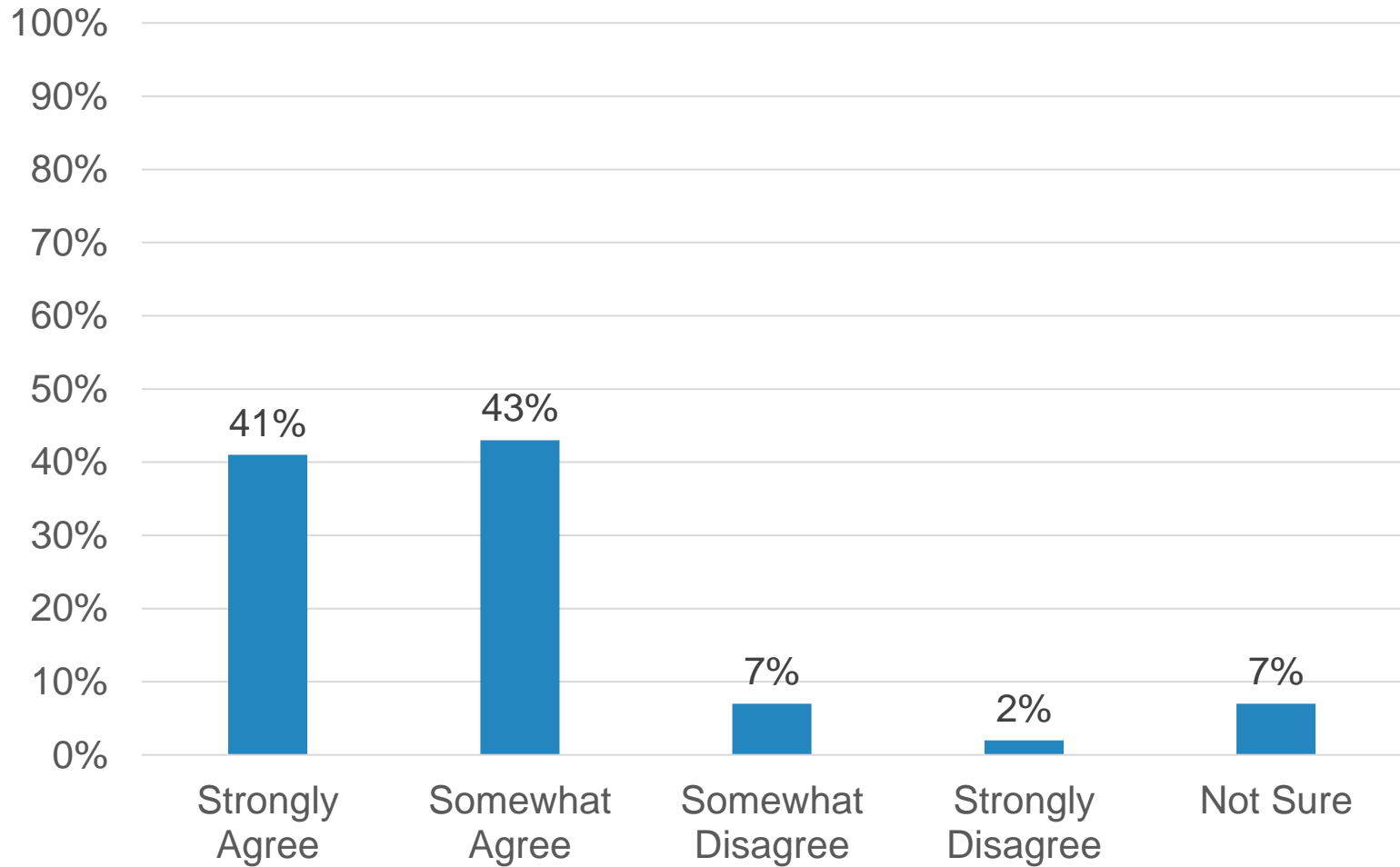

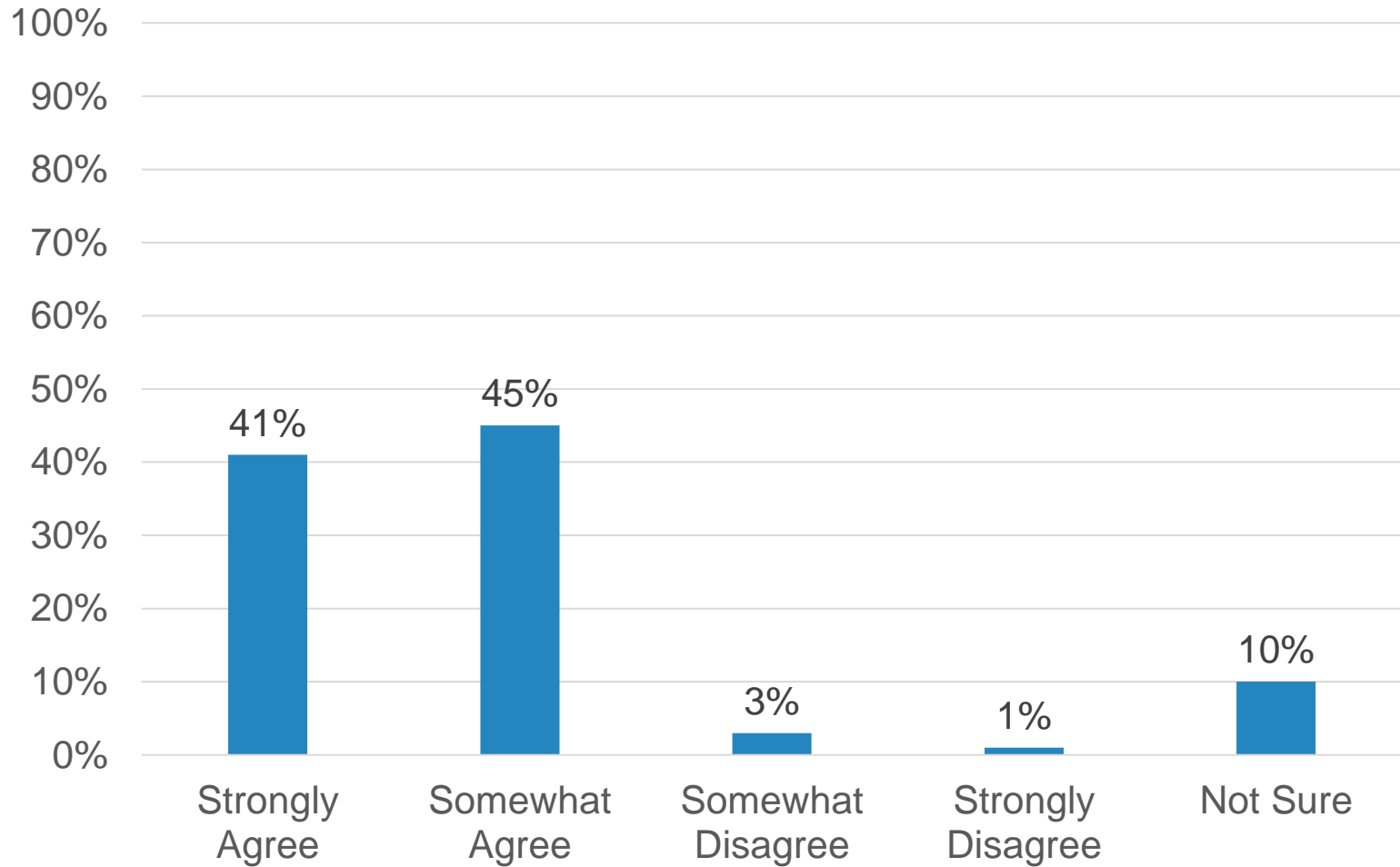

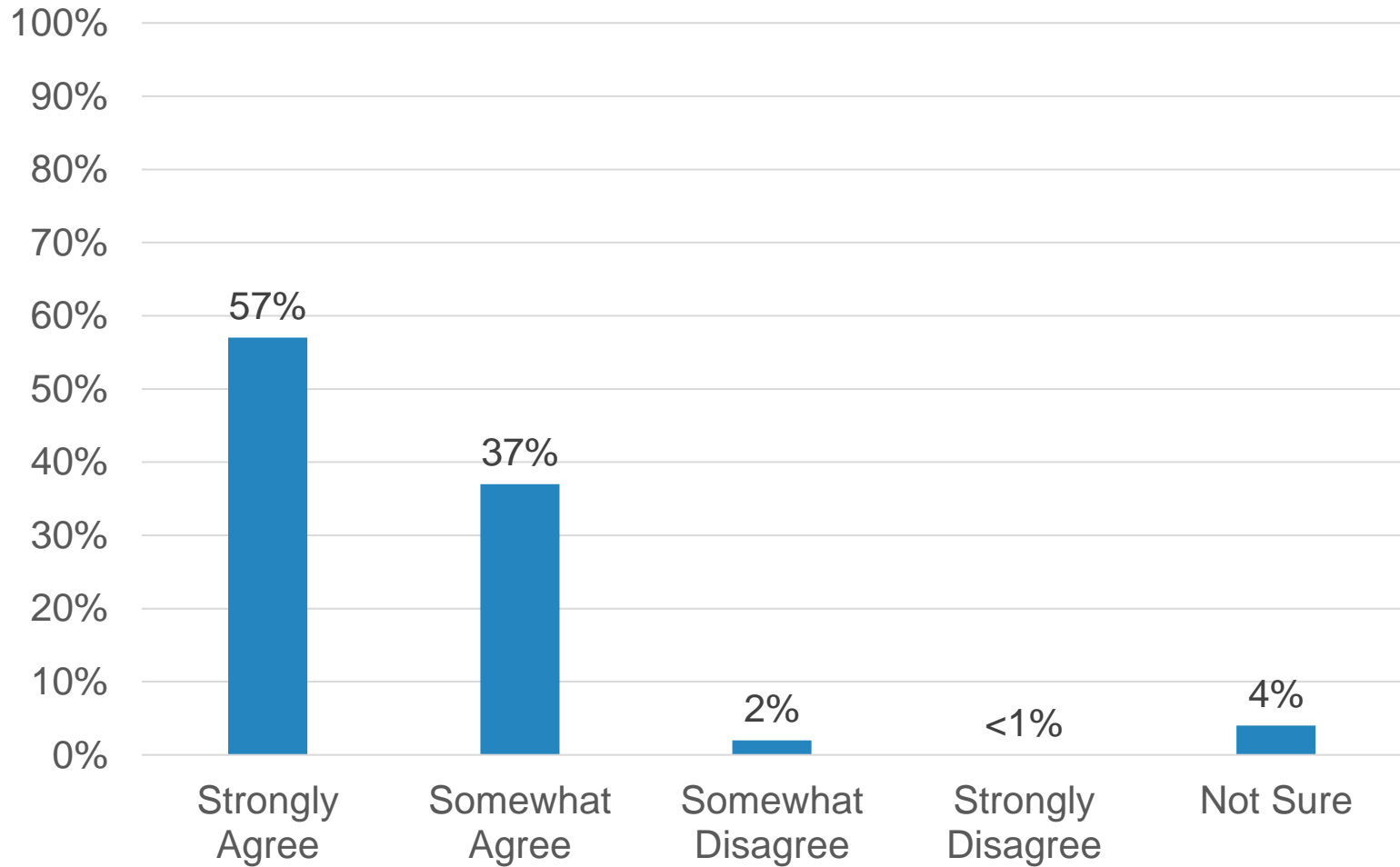

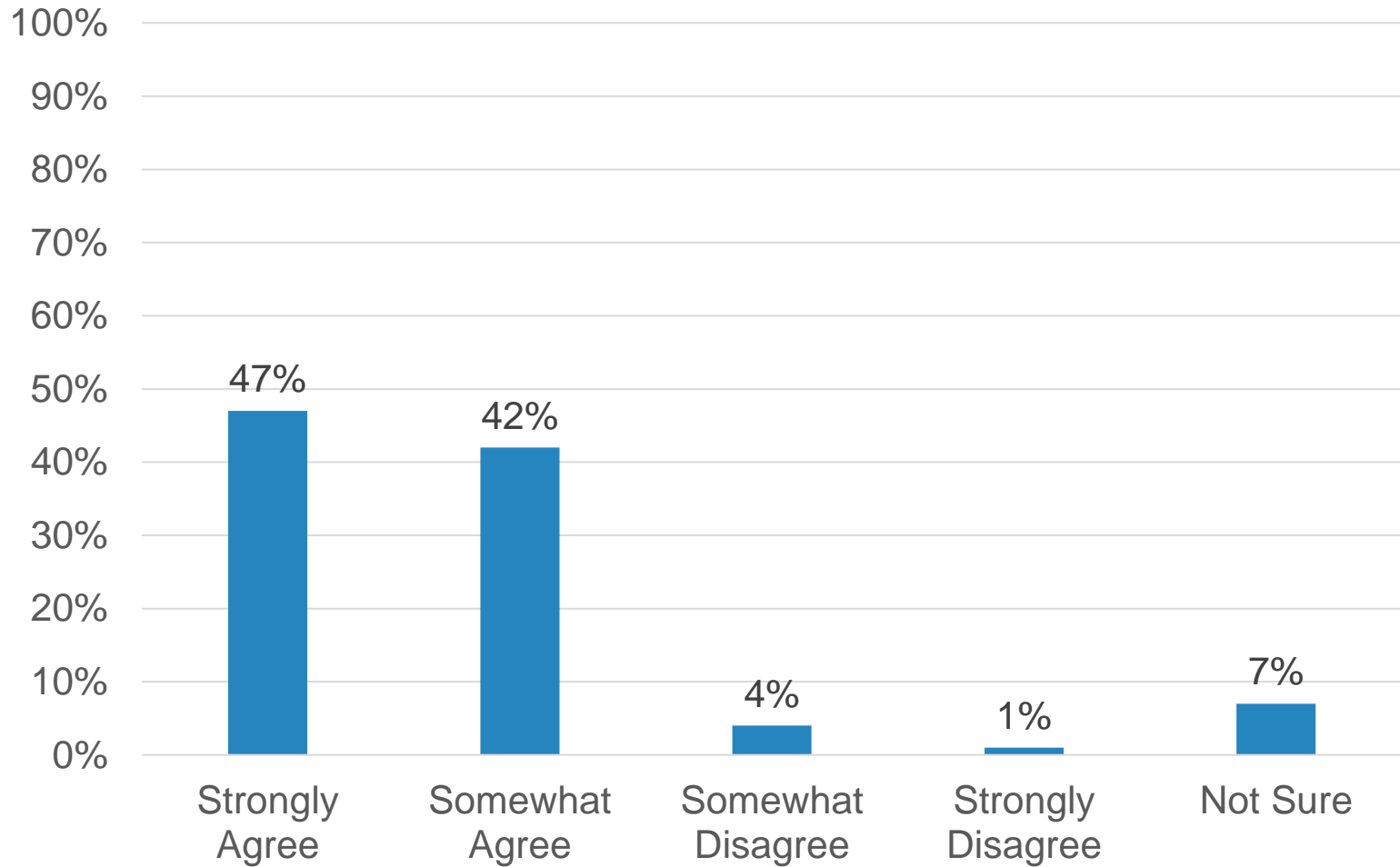

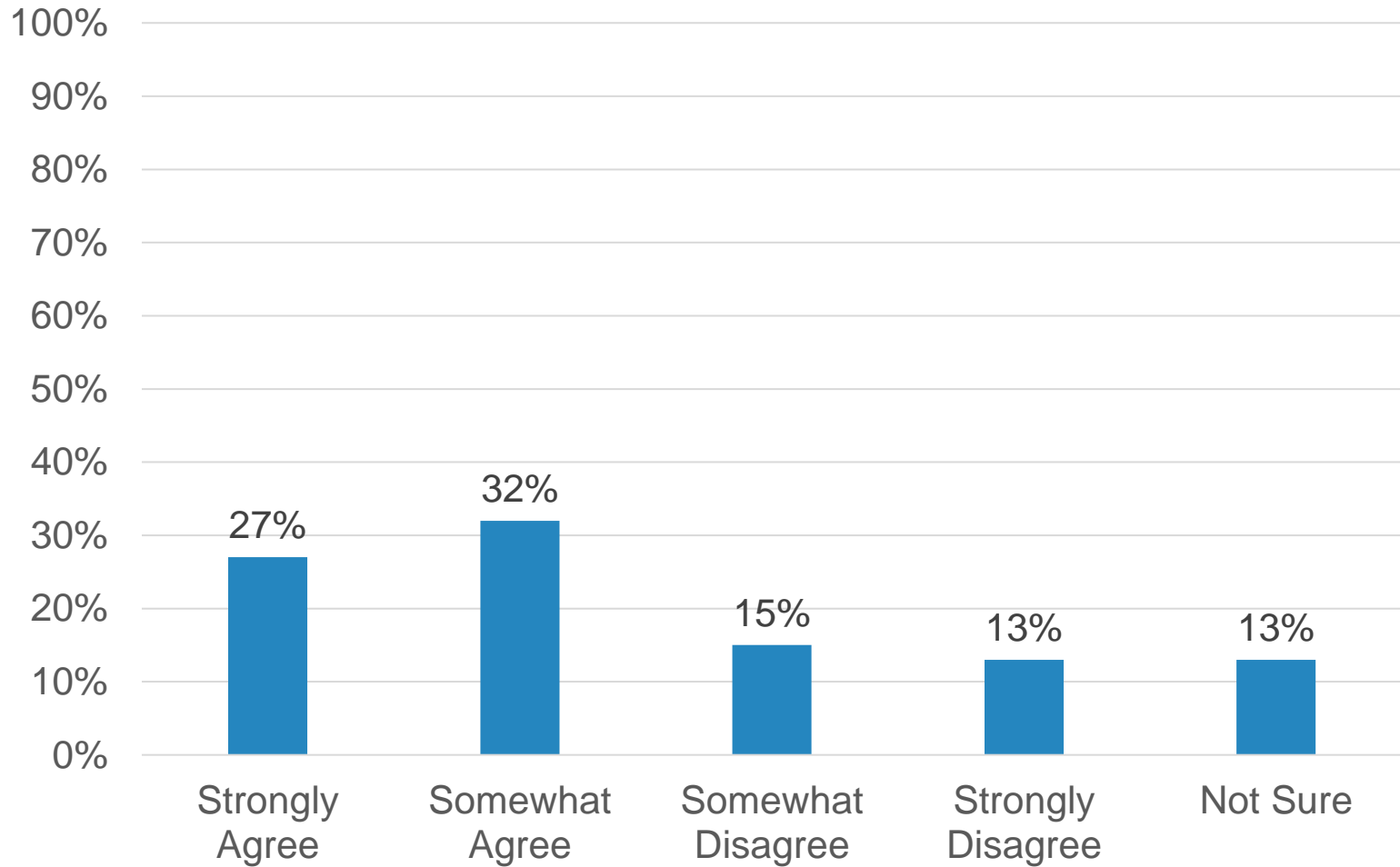

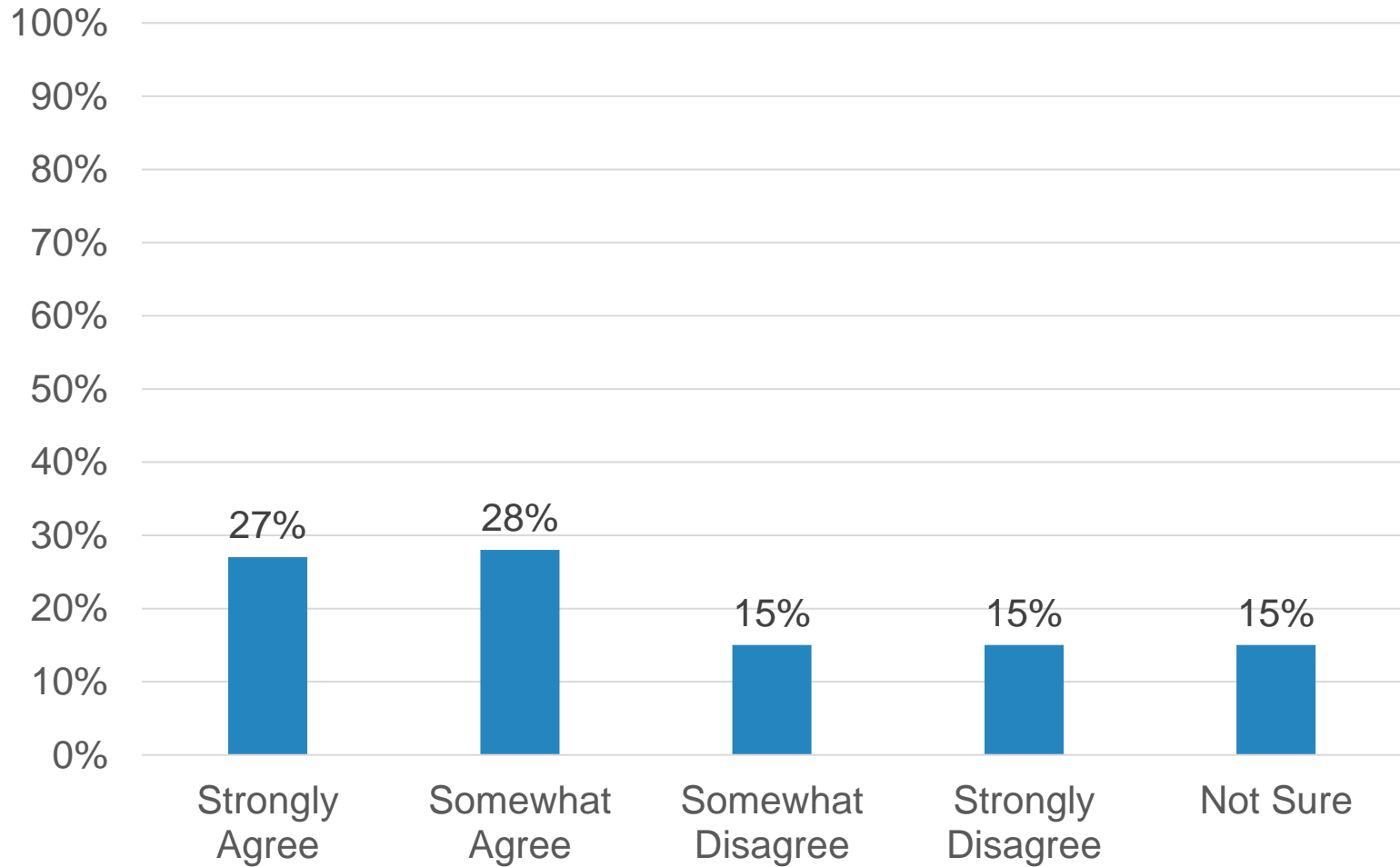

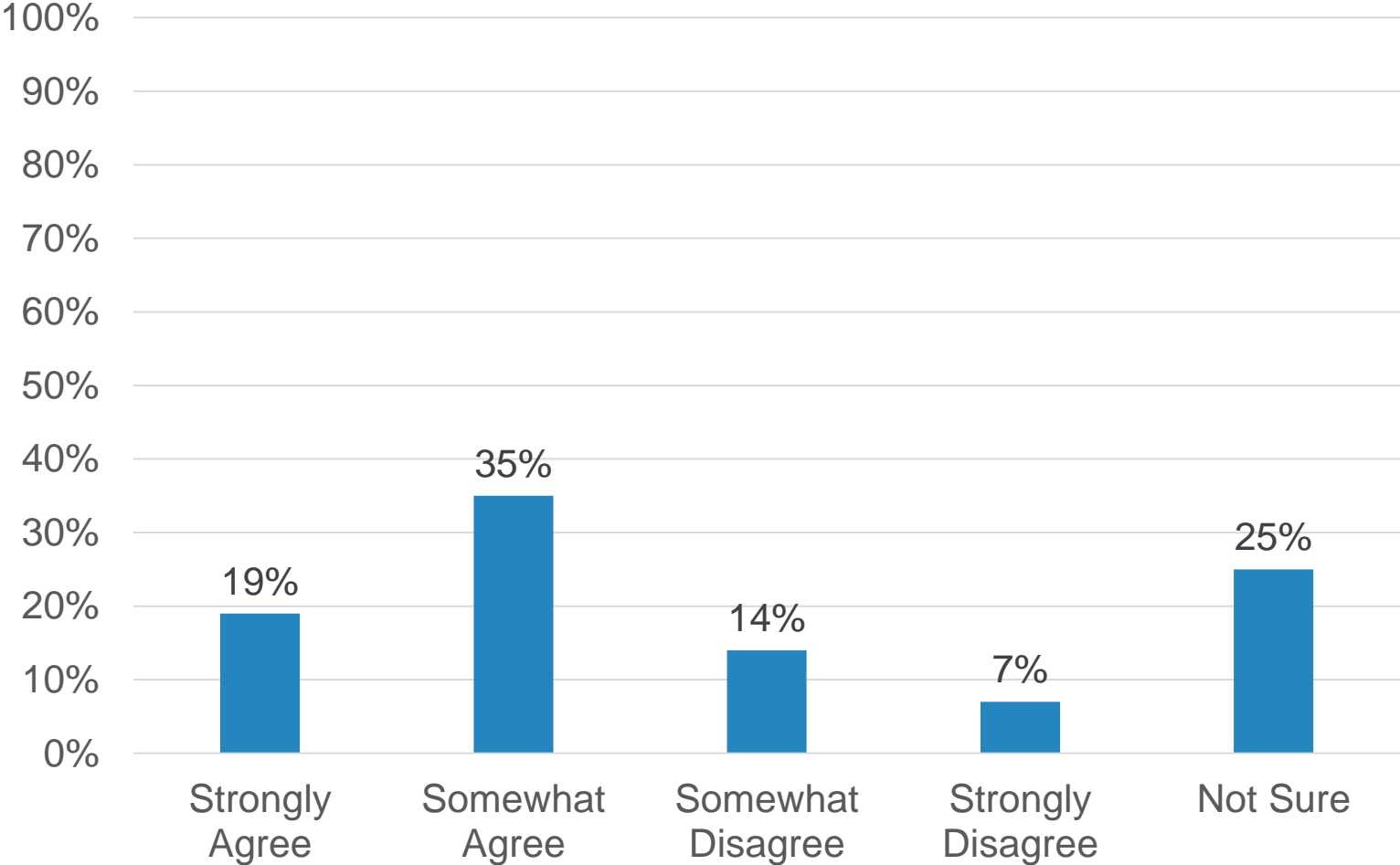

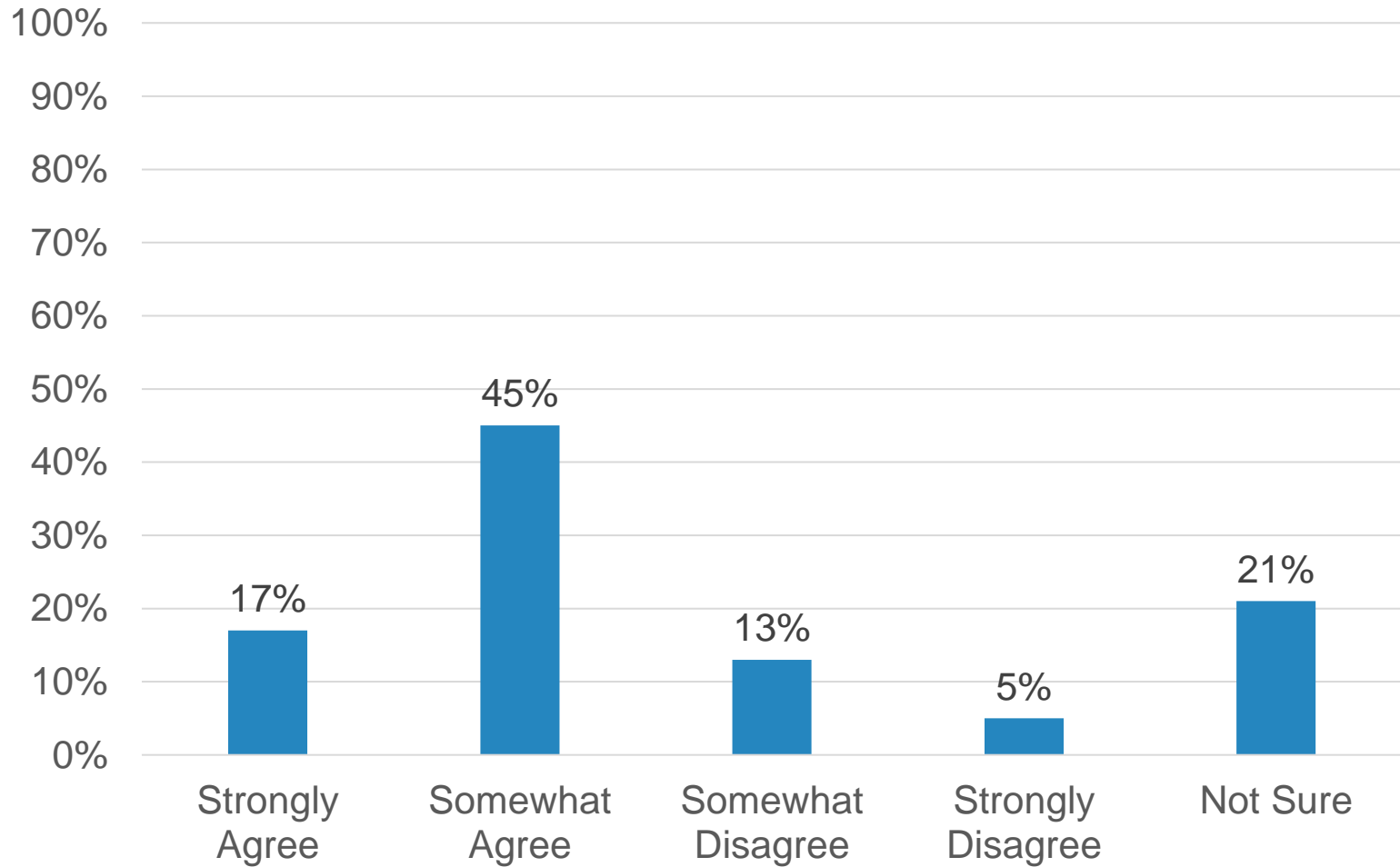

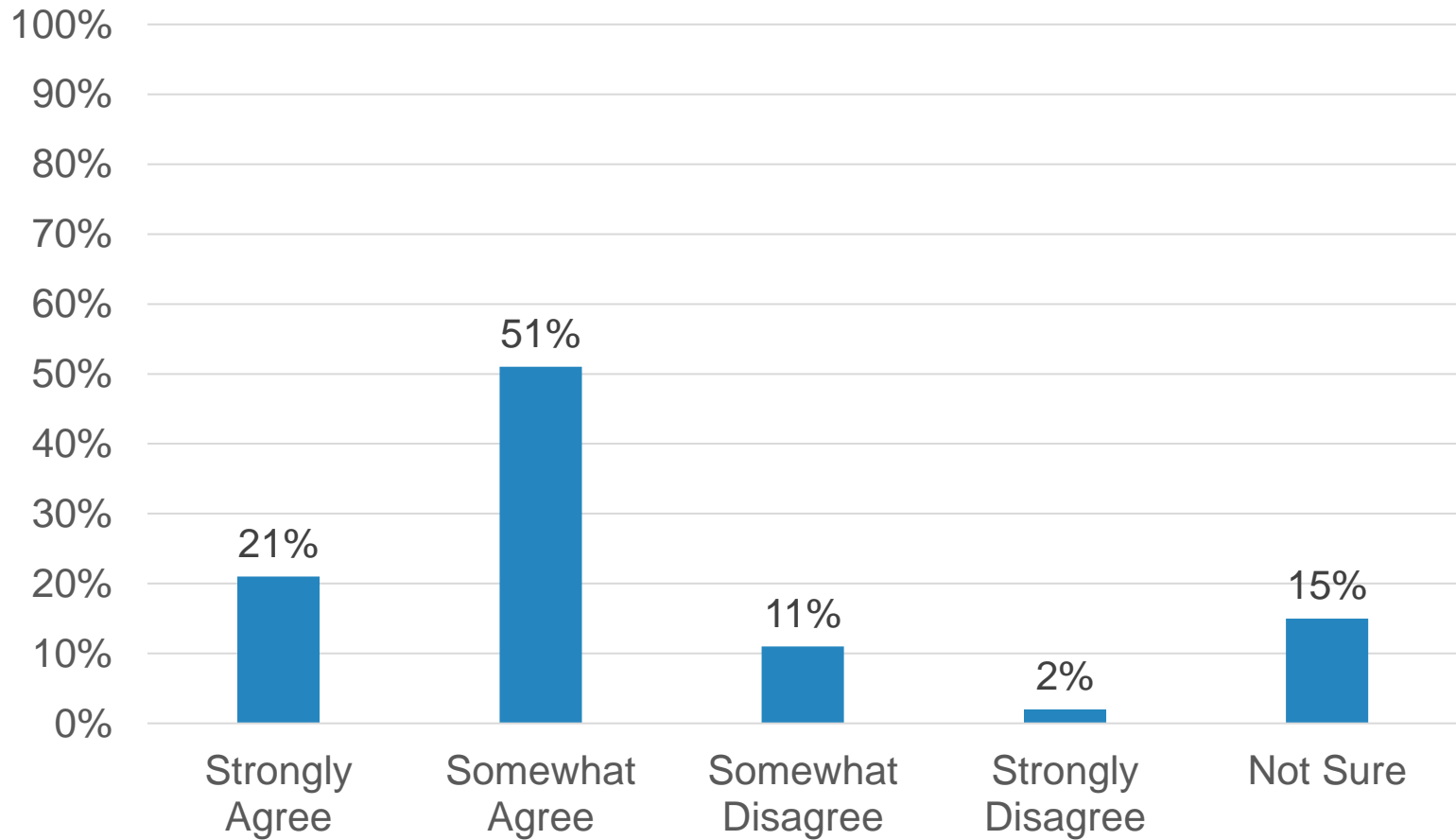

# Significant Statistical Differences

Comparisons were made to determine if there are any significant statistical differences among worship service attendance, church size, and evangelical beliefs.

# Definitions

- **Evangelical Beliefs** are defined using the NAE Lifeway Research Evangelical Beliefs Research Definition based on respondent beliefs
- Respondents are asked their level of agreement with four separate statements using a four-point, forced choice scale (strongly agree, somewhat agree, somewhat disagree, strongly disagree). Those who strongly agree with all four statements are categorized as having Evangelical Beliefs
  - The Bible is the highest authority for what I believe
  - It is very important for me personally to encourage non-Christians to trust Jesus Christ as their Savior
  - Jesus Christ's death on the cross is the only sacrifice that could remove the penalty of my sin
  - Only those who trust in Jesus Christ alone as their Savior receive God's free gift of eternal salvation

### **Writing letters or cards to prisoners**

- Those age 18-29 (27%) and 30-49 (28%) are more likely to select “I have participated in the past” than those age 50-64 (14%) and 65+ (9%)
- Those age 65+ are the most likely to select “No past experience” (71%)
- Those in the South (54%) and West (56%) are more likely to select “No past experience” than those in the Northeast (43%)
- African Americans (26%) and Hispanics (27%) are more likely to select “I have participated in the past” than Whites (14%)
- Those with some college are the least likely to select “No past experience” (45%)
- Those who attend a worship service once a month (63%) are more likely to select “No past experience” than those who three times a month (45%)
- Those who attend churches with attendance of less than 50 (23%) are more likely to select “I have only heard of this outside my church, but I have not participated” than those at churches with attendance of 50-99 (14%) and 250-499 (10%)

## In-person visits to prisoners

- Those age 65+ are the most likely to select “No past experience” (69%)
- Those age 18-29 (22%) and 30-49 (21%) are more likely to select “My church has engaged in this, but I have not participated” than those age 50-64 (12%) and 65+ (9%)
- Those in the Northeast (22%) and South (21%) are more likely to select “I have participated in the past” than those in the Midwest (12%)
- African Americans (27%) are more likely to select “I have participated in the past” than Whites (15%)
- Those who are High School Graduates or less (59%) are more likely to select “No past experience” than those with some college (47%)
- Those who attend a worship service once a month (67%) are more likely to select “No past experience” than those who three times a month (44%) and 4 or more times a month (53%)
- Those who attend churches with attendance of 100-249 (16%) and 250-599 (19%) are more likely to select “My church has engaged in this, but I have not participated” than those at churches with attendance of less than 50 (8%)

- Those who attend a worship service once a month are the most likely to select “No past experience” (72%)
- Those who attend churches with attendance of less than 50 (63%) are more likely to select “No past experience” than those at churches with attendance of less than 100-249 (52%)

### **Assisting families with loved ones in prison**

- Those age 65+ are the most likely to select “No past experience” (72%)
- Those age 18-29 (34%) and 30-49 (32%) are more likely to select “I have participated in the past” than those age 50-64 (23%) and 65+ (12%)
- Those in the Northeast (30%) are more likely to select “I have participated in the past” than those in the Midwest (18%)
- Whites are the most likely to select “No past experience” (57%)
- African Americans (35%), Hispanics (37%), and Other Ethnicities (31%) are more likely to select “I have participated in the past” than Whites (17%)
- Those who are High School Graduates or less are the most likely to select “No past experience” (59%)
- Those who attend a worship service three times a month (28%) or 4 or more times a month (25%) are more likely to select “I have participated in the past” than those who once a month (11%)
- Those who attend churches with attendance of 100-249 (29%) are more likely to select “I have participated in the past” than those at churches with attendance of less than 50 (18%) and 500+ (17%)

- Those who are High School Graduates or less are the most likely to select “No past experience” (60%)
- Those who attend a worship service three times a month (21%) or 4 or more times a month (22%) are more likely to select “I have participated in the past” than those who once a month (11%)
- Those who attend churches with attendance of less than 50 (62%) are more likely to select “No past experience” than those at churches with attendance of 50-99 (51%), 100-249 (49%) and 500+ (50%)

## Foster parenting for children

- Those age 65+ are the most likely to select “No past experience” (82%)
- Those age 18-29 are the most likely to select “My church has engaged in this, but I have not participated” (26%)
- Whites (68%) and African Americans (64%) are more likely to select than Hispanics (49%)
- Those who are High School Graduates or less are the most likely to select “No past experience” (71%)
- Those who attend a worship service once a month (76%) are more likely to select “No past experience” than those who twice a month (63%) or three times a month (56%)
- Those who attend churches with attendance of less than 50 (73%) are more likely to select “No past experience” than those at churches with attendance of 50-99 (62%)

## **“Indicate the response that best describes your experience with each of the following types of prison ministry?”**

### **In-person aftercare ministry with former prisoners**

- Those age 65+ are the most likely to select “No past experience” (81%)
- Those age 18-29 (23%) and 30-49 (21%) are more likely to select “My church has engaged in this, but I have not participated” than those age 50-64 (13%) and 65+ (4%)
- Whites (66%) are more likely to select “No past experience” than African Americans (56%) and Hispanics (47%)
- Hispanics (20%) are more likely to select “I have participated in the past” than Whites (7%) and Other Ethnicities (7%)
- Those who attend a worship service once a month (72%) are more likely to select “No past experience” than those who three times a month (55%)

## Writing letters or cards to prisoners

- Those age 18-29 (37%) and 30-49 (37%) are more likely to select “Very interested” than those 50-64 (14%) and 65+ (11%)
- Those in the West (40%) are more likely to select “Not at all interested” than those in the Northeast (27%) and South (31%)
- African Americans (30%) and Hispanics (29%) are more likely to select “Very interested” than Whites (18%)
- Those with a Graduate Degree (39%) are more likely to select “Not at all interested” than those with some college (29%) or a Bachelor’s Degree (29%)
- Those who attend a worship service three times a month (26%) or 4 or more times a month (23%) are more likely to select “Very interested” than those who once a month (14%) or twice a month (16%)
- Those who attend churches with attendance of 50-99 (27%) are more likely to select “Very interested” than those at churches with attendance of less than 50 (18%) and 250-499 (17%)

- Females are more likely to select “Not at all interested” than males (56% v. 42%)
- Those age 65+ are more likely to select “Not at all interested” (73%)
- Those age 18-29 (21%) and 30-49 (27%) are more likely to select “Very interested” than those 50-64 (12%) and 65+ (4%)
- Whites (55%) are more likely to select “Not at all interested” than African Americans (39%) and Hispanics (41%)
- Those who are High School Graduates or less (56%) are more likely to select “Not at all interested” than with some college (46%) or a Bachelor’s Degree (42%)
- Those who attend a worship service once a month (60%) are more likely to select “Not at all interested” than those who twice a month (42%)
- Those who attend churches with attendance of 50-99 (20%) are more likely to select “Very interested” than those at churches with attendance of less than 50 (10%), 250-499 (11%), and 500+ (9%)

- Females are more likely to select “Not at all interested” than males (53% v. 43%)
- Those age 65+ are the most likely to select “Not at all interested” (71%)
- Those age 18-29 (25%) and 30-49 (28%) are more likely to select “Very interested” than those 50-64 (12%) and 65+ (6%)
- Those in the West (55%) are more likely to select “Not at all interested” than those in the South (45%)
- African Americans (23%) are more likely to select “Very interested” than Whites (13%)
- Those who are High School Graduates or less (54%) or with a Graduate Degree (57%) are more likely to select “Not at all interested” than with some college (43%) or a Bachelor’s Degree (42%)
- Those who attend a worship service once a month are the most likely to select “Not at all interested” (67%)
- Those who attend churches with attendance of 250-499 (57%) and 500+ (55%) are more likely to select “Very interested” than those at churches with attendance of 100-249 (43%)

- Those age 65+ are the most likely to select “Not at all interested” (49%)
- Those age 18-29 (38%) and 30-49 (37%) are more likely to select “Very interested” than those 50-64 (20%) and 65+ (9%)
- Those in the Northeast (32%) are more likely to select “Very interested” than those in the Midwest (22%) and South (23%)
- African Americans (35%) are more likely to select “Very interested” than Whites (19%) and Other Ethnicities (21%)
- Those who are High School Graduates or less (34%) or with a Graduate Degree (30%) are more likely to select “Not at all interested” than with some college (20%) or a Bachelor’s Degree (21%)
- Those who attend a worship service once a month are the least likely to select “Very interested” (12%)
- Those who attend churches with attendance of 50-99 (29%) are more likely to select “Very interested” than those at churches with attendance of 250-499 (17%)

- Those age 18-29 are the most likely to select (38%)
- Those age 65+ are the least likely to select (15%)
- Those in the Northeast (34%) are more likely to select than those in the Midwest (21%) and South (21%)
- Whites are the least likely to select (19%)
- Those with some college are the most likely to select (33%)
- Those who attend churches with attendance of 50-99 (28%) are more likely to select than those at churches with attendance of 250-499 (18%) and 500+ (18%)

- Those who attend churches with attendance of 100-249 (87%) and 500+ (89%) are more likely to Agree than those at churches with attendance of less than 50 (79%) and 50-99 (80%)
- Those with evangelical beliefs are more likely to Agree than those without evangelical beliefs (90% v. 78%)

## **“Prison ministry contributes positively to public safety.”**

- Those with a Bachelor’s Degree (89%) or a Graduate Degree (92%) are more likely to Agree than those who are High School Graduates or less (81%)

- African Americans are the most likely to Agree (89%)
- Those with some college (65%) or a Bachelor’s Degree (63%) are more likely to Agree than those who are High School Graduates or less (52%)
- Those who attend churches with attendance of 50-99 (66%) are more likely to Agree than those at churches with attendance of 250-499 (54%) and 500+ (50%)
- Those without evangelical beliefs are more likely to Agree than those with evangelical beliefs (65% v. 54%)

## **“The racial disparity within the prisoner population in America is unjust.”**

- Males are more likely to Disagree than females (39% v. 24%)
- Those age 18-29 (71%) and 30-49 (69%) are more likely to Agree than those 50-64 (52%) and 65+ (37%)
- Those age 50-64 are the most likely to Disagree (35%)
- African Americans are the most likely to Agree (89%) and Whites are the least likely to Agree (41%)
- Those with some college (60%) or a Bachelor’s Degree (60%) are more likely to Agree than those who are High School Graduates or less (47%)
- Those who attend a worship service three times a month (63%) are more likely to Agree than those who attend twice a month (52%) or 4 or more times a month (53%)
- Those who attend churches with attendance of less than 50 (55%), 50-99 (60%), 100-249 (56%) are more likely to Agree than those at churches with attendance of 500+ (42%)
- Those without evangelical beliefs are more likely to Agree than those with evangelical beliefs (63% v. 47%)



## **“Having difficulty re-entering society from jail and prison is an issue in my community.”**

- Those age 18-29 (66%) and 30-49 (68%) are more likely to Agree than those 50-64 (52%) and 65+ (38%)
- African Americans (68%) and Hispanics (63%) are more likely to Agree than Whites (48%)
- Those who attend a worship service twice a month (63%) are more likely to Agree than those who attend once a month (49%) or 4 or more times a month (52%)
- Those who attend churches with attendance of 50-99 (59%) are more likely to Agree than those at churches with attendance of 500+ (46%)

## **“Many jails and prisons offer rehabilitation programs for those in custody.”**

- Those age 18-29 (26%) are more likely to Disagree than those 50-64 (17%) and 65+ (11%)
- Hispanics (70%) are more likely to Agree than Other Ethnicities (51%)

**“Prisoners participating in rehabilitation programs in prison are much less likely to commit another offense.”**

- Those with a Graduate Degree (79%) are more likely to Agree than those who are High School Graduates or less (67%)
