



There are four areas of influence that provide guidance for your interactions with inmates in a correctional setting . . .

- 1. Legal guidelines
- 2. Correctional guidelines

And to these I'll add two more . . .

- 3. Biblical principles
- 4. Practical consideration for the person

WHAT BIBLICAL PRINCIPLES SHOULD INFLUENCE HOW YOU RELATE TO PEOPLE?



Four biblical passages urge you to display balance.

1 TIMOTHY 2:1-4

HOW DO YOU MAINTAIN BALANCE?

- Remember that God desires all people to come to the knowledge of the truth (1 Tim. 2:1-4).
- But God commands us to communicate truth to them gently (2 Tim. 2:24-26)!
- Remember that God must provide an open door to share Christ (Col. 4:2-4).
- But God commands us to walk through that door with wisdom (Col. 4:5-6)!

HOW DO YOU DISPLAY WISDOM AS YOU INTERACT WITH OTHERS ABOUT SPIRITUAL TRUTH?



These passages of Scripture tell us how!

1ST

BE SPIRITUALLY SENSITIVE AND OPPORTUNISTIC.

COLOSSIANS 4:5-6

- v. 5 Conduct yourselves with wisdom toward outsiders, making the most of the opportunity.

2ND

START FROM THE OTHER PERSON'S PERSPECTIVE, NOT YOURS!

1 CORINTHIANS 9:19-22

- v. 19 For though I am free from all *men*,
 I have made myself a slave to all,
 that I might win more;
- v. 20 to the Jews I became as a Jew, that I might win Jews;
 - to those who are under the Law, as under the Law that I might win those who are under the Law;
- v. 21 to those who are without law, as without law that I might win those who are without law;
- v. 22 to the weak, I became weak, that I might win the weak.
 - I have become all things to all men, that I may by all means save some.

This means you must:

- → Accept them . . .
 as they are, regardless of their background.
- → Adapt to them . . . because of their background.
- → Appeal to them . . . by building a bridge based on their background.

3RD

USE GOOD JUDGMENT TO PUT THE OTHER PERSON AT EASE.

- → You will interact with others who are skeptical or hostile.
- → You must display a non-threatening presence to "disarm" people.
- → And since it is not your role to establish facility policy, but to respond based on facility policy . . .

BE CAUTIOUS WITH YOUR WORDING!

- You never say things like . . .
 - I can't allow you to have that.
 - I can't give you that.
 - I can't approve that.
- Because you are under facility authority, you say things like:
 - Facility policy doesn't allow that, however it allows you to . . .
 - Facility policy allows you to practice your faith by . . .
 - The facility allows that and for me to facilitate that for you by . . .

PRAY FOR BOLDNESS AS YOU SENSE A POSSIBLE OPEN DOOR.

USE QUESTIONS TO LEAD PEOPLE TO A DISCOVERY OF SPIRITUAL TRUTH.

Jesus often used questions when relating to His followers:

- Is not life more than food and the body more than clothing?
- Who do men say that I, the Son of Man, am?
- But who do you say that I am?

Jesus used questions with those who opposed Him:

- Which is easier to say . . . "Your sins are forgiven you," or to say, "Arise, take up your bed and walk?"
- What do you think about the Christ?
- Whose Son is He?

LEARN TO USE QUESTIONS EFFECTIVELY!

How?

- To discern interest in spiritual things in a nonthreatening way.
- To increase the desire for the person to listen.
- To move the conversation toward spiritual truth.
- To obtain permission to interact with them about biblical truth.




HOW DO YOU DISPLAY **PRACTICAL CONSIDERATION FOR** THE PERSON?



In obtaining permission to share biblical truth . . . and how you obtain it!



AS TIME PASSES DURING THE CONVERSATION ...



ALLOW IT TO FLOW FROM SECULAR TO SPIRITUAL SUBJECTS.

Here's a quick explanation of the key points.

1. Begin by praying that God will provide an "open door" for the gospel.

2. Don't start by talking, ask questions that encourage them to talk!

- 3. Engage in ordinary, everyday, non-threatening, casual conversation that usually revolves around three main subjects:
 - Where they're from (local or from out of town?)
 - What they do (student or professional person?)
 - Who they know (family or close friends?)

How do you know if you should "go for it"?

If they're receptive to you as a person, that *may* be an opportunity to talk further and *may* become an opportunity to talk about spiritual things.

If they're *not* receptive to you as a person, back off!

4. As you converse be sensitive to natural opportunities you may have to smoothly move the conversation to spiritual things based on something they already said:

- 4. As you converse be sensitive to natural opportunities you may have to smoothly move the conversation to spiritual things based on something they already said:
 - a. Them: "I lost my best friend in a car accident last week." [Or] "My wife walked out on me." [Or] "My company downsized and I lost my job." You: "That's horrible, how are you handling that?"
 - b. Them: "I'm not handling things very well, but a friend at church is praying for me." [Or] "With all the turmoil in the world, I don't know what to expect next." [Or] "I'm still trying to find peace in my life."

You: "I know what you mean. Some people find comfort in their faith."

5. As you converse and listen, ask questions based on something they already said that focuses more directly on spiritual things:

- 5. As you converse and listen, ask questions based on something they already said that focuses more directly on spiritual things:
 - "Have you ever thought about how spiritual things may relate to that?"
 - "Are you interested in spiritual things?"
 - "That's an interesting statement . . . what is your spiritual background?"
 - "Would you tell me about that?"

6. As you converse and listen, ask questions that enables <u>them</u> to give <u>you</u> clear permission to discuss spiritual truth:


- As you converse and listen, ask questions that enables <u>them</u> to give <u>you</u> clear permission to discuss spiritual truth:
 - "As a Christian, the only way I can respond to your question is from a biblical viewpoint. Would you like me to do that?"
 - "Well again, the perspective I'd use to comment on that is based on the Bible. "Would you like me to do that?"

- 7. Ask specific questions that *may* enable you to present the gospel:
 - "May I ask you a very personal question?"
 - "Have you come to the point spiritually where you know you'd go to heaven, or are you somewhere along the way?"
 - "If you were to die and God asked you, 'Why should I let you into heaven?' what would you tell Him?"
 - "Has anyone ever shown you from the Bible how you could know you'd go to heaven?"
 - "If I could show you how you could know your sins are forgiven and you could go to heaven, would that interest you?"
 - "May I do that?"

8. Clearly dialogue with them about the gospel!


